A BILL

Making appropriations for the Departments of Labor, Health and Human Services, and Education, and related agencies, for the fiscal year ending September 30, 1997, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 That the following sums are appropriated, out of any
4 money in the Treasury not otherwise appropriated, for the
5 Departments of Labor, Health and Human Services, and

1 Education, and related agencies for the fiscal year ending
2 September 30, 1997, and for other purposes, namely:

3 TITLE I—DEPARTMENT OF LABOR

4 EMPLOYMENT AND TRAINING ADMINISTRATION

5 TRAINING AND EMPLOYMENT SERVICES

6 For expenses necessary to carry into effect the Job
7 Training Partnership Act, as amended, including the pur-
8 chase and hire of passenger motor vehicles, the construc-
9 tion, alteration, and repair of buildings and other facili-
10 ties, and the purchase of real property for training centers
11 as authorized by the Job Training Partnership Act; the
12 Women in Apprenticeship and Nontraditional Occupations
13 Act; the National Skill Standards Act of 1994; and the
14 School-to-Work Opportunities Act; \$4,171,482,000 plus
15 reimbursements, of which \$3,297,011,000 is available for
16 obligation for the period July 1, 1997 through June 30,
17 1998; of which \$73,861,000 is available for the period
18 July 1, 1997 through June 30, 2000 for necessary ex-
19 penses of construction, rehabilitation, and acquisition of
20 Job Corps centers; and of which \$175,000,000 shall be
21 available from July 1, 1997 through September 30, 1998,
22 for carrying out activities of the School-to-Work Opportu-
23 nities Act: *Provided*, That \$50,000,000 shall be for carry-
24 ing out section 401 of the Job Training Partnership Act,
25 \$65,000,000 shall be for carrying out section 402 of such

1 Act, \$7,300,000 shall be for carrying out section 441 of
2 such Act, \$2,530,000 shall be for all activities conducted
3 by and through the National Occupational Information
4 Coordinating Committee under such Act, \$850,000,000
5 shall be for carrying out title II, part A of such Act, and
6 \$126,672,000 shall be for carrying out title II, part C of
7 such Act: *Provided further*, That no funds from any other
8 appropriation shall be used to provide meal services at or
9 for Job Corps centers: *Provided further*, That funds pro-
10 vided to carry out title III of the Job Training Partnership
11 Act shall not be subject to the limitation contained in sub-
12 section (b) of section 315 of such Act; that the waiver
13 allowing a reduction in the cost limitation relating to re-
14 training services described in subsection (a)(2) of such
15 section 315 may be granted with respect to funds from
16 this Act if a substate grantee demonstrates to the Gov-
17 ernor that such waiver is appropriate due to the availabil-
18 ity of low-cost retraining services, is necessary to facilitate
19 the provision of needs-related payments to accompany
20 long-term training, or is necessary to facilitate the provi-
21 sion of appropriate basic readjustment services; and that
22 funds provided to carry out the Secretary's discretionary
23 grants under part B of such title III may be used to pro-
24 vide needs-related payments to participants who, in lieu
25 of meeting the requirements relating to enrollment in

1 training under section 314(e) of such Act, are enrolled in
2 training by the end of the sixth week after grant funds
3 have been awarded: *Provided further*, That service delivery
4 areas may transfer funding provided herein under author-
5 ity of titles II–B and II–C of the Job Training Partner-
6 ship Act between the programs authorized by those titles
7 of that Act, if such transfer is approved by the Governor:
8 *Provided further*, That service delivery areas and substate
9 areas may transfer funding provided herein under author-
10 ity of title II–A and title III of the Job Training Partner-
11 ship Act between the programs authorized by those titles
12 of the Act, if such transfer is approved by the Governor:
13 *Provided further*, That, notwithstanding any other provi-
14 sion of law, any proceeds from the sale of Job Corps center
15 facilities shall be retained by the Secretary of Labor to
16 carry out the Job Corps program.

17 COMMUNITY SERVICE EMPLOYMENT FOR OLDER

18 AMERICANS

19 (TRANSFER OF FUNDS)

20 To carry out the activities for national grants or con-
21 tracts with public agencies and public or private nonprofit
22 organizations under paragraph (1)(A) of section 506(a)
23 of title V of the Older Americans Act of 1965, as amended,
24 or to carry out older worker activities as subsequently au-
25 thorized, \$242,450,000.

1 To carry out the activities for grants to States under
2 paragraph (3) of section 506(a) of title V of the Older
3 Americans Act of 1965, as amended, or to carry out older
4 worker activities as subsequently authorized,
5 \$130,550,000.

6 The funds appropriated under this heading shall be
7 transferred to the Department of Health and Human
8 Services, "Aging Services Programs" following the enact-
9 ment of legislation authorizing the administration of the
10 program by that Department: *Provided*, That the funds
11 shall be available for obligation for the period July 1, 1997
12 through June 30, 1998.

13 FEDERAL UNEMPLOYMENT BENEFITS AND ALLOWANCES

14 For payments during the current fiscal year of trade
15 adjustment benefit payments and allowances under part
16 I, and for training, for allowances for job search and relo-
17 cation, and for related State administrative expenses
18 under part II, subchapters B and D, chapter 2, title II
19 of the Trade Act of 1974, as amended, \$324,500,000, to-
20 gether with such amounts as may be necessary to be
21 charged to the subsequent appropriation for payments for
22 any period subsequent to September 15 of the current
23 year.

1 STATE UNEMPLOYMENT INSURANCE AND EMPLOYMENT
2 SERVICE OPERATIONS

3 For authorized administrative expenses,
4 \$132,279,000, together with not to exceed
5 \$3,096,111,000 (including not to exceed \$1,653,000
6 which may be used for amortization payments to States
7 which had independent retirement plans in their State em-
8 ployment service agencies prior to 1980, and including not
9 to exceed \$2,000,000 which may be obligated in contracts
10 with non-State entities for activities such as occupational
11 and test research activities which benefit the Federal-
12 State Employment Service System), which may be ex-
13 pended from the Employment Security Administration ac-
14 count in the Unemployment Trust Fund, and of which the
15 sums available in the allocation for activities authorized
16 by title III of the Social Security Act, as amended (42
17 U.S.C. 502–504), and the sums available in the allocation
18 for necessary administrative expenses for carrying out 5
19 U.S.C. 8501–8523, shall be available for obligation by the
20 States through December 31, 1997, except that funds
21 used for automation acquisitions shall be available for obli-
22 gation by States through September 30, 1999; and of
23 which \$132,279,000, together with not to exceed
24 \$701,369,000 of the amount which may be expended from
25 said trust fund, shall be available for obligation for the

1 period July 1, 1997 through June 30, 1998, to fund ac-
2 tivities under the Act of June 6, 1933, as amended, in-
3 cluding the cost of penalty mail made available to States
4 in lieu of allotments for such purpose, and of which
5 \$260,573,000 shall be available only to the extent nec-
6 essary for additional State allocations to administer unem-
7 ployment compensation laws to finance increases in the
8 number of unemployment insurance claims filed and
9 claims paid or changes in a State law: *Provided*, That to
10 the extent that the Average Weekly Insured Unemploy-
11 ment (AWIU) for fiscal year 1997 is projected by the De-
12 partment of Labor to exceed 2,828,000 an additional
13 \$28,600,000 shall be available for obligation for every
14 100,000 increase in the AWIU level (including a pro rata
15 amount for any increment less than 100,000) from the
16 Employment Security Administration Account of the Un-
17 employment Trust Fund: *Provided further*, That funds ap-
18 propriated in this Act which are used to establish a na-
19 tional one-stop career center network may be obligated in
20 contracts, grants or agreements with non-State entities:
21 *Provided further*, That funds appropriated under this Act
22 for activities authorized under the Wagner-Peyser Act, as
23 amended, and title III of the Social Security Act, may be
24 used by the States to fund integrated Employment Service
25 and Unemployment Insurance automation efforts, not-

1 withstanding cost allocation principles prescribed under
 2 Office of Management and Budget Circular A–87.

3 ADVANCES TO THE UNEMPLOYMENT TRUST FUND AND
 4 OTHER FUNDS

5 For repayable advances to the Unemployment Trust
 6 Fund as authorized by sections 905(d) and 1203 of the
 7 Social Security Act, as amended, and to the Black Lung
 8 Disability Trust Fund as authorized by section 9501(e)(1)
 9 of the Internal Revenue Code of 1954, as amended; and
 10 for nonrepayable advances to the Unemployment Trust
 11 Fund as authorized by section 8509 of title 5, United
 12 States Code, section 104(d) of Public Law 102–164, and
 13 section 5 of Public Law 103–6, and to the “Federal unem-
 14 ployment benefits and allowances” account, to remain
 15 available until September 30, 1998, \$373,000,000.

16 In addition, for making repayable advances to the
 17 Black Lung Disability Trust Fund in the current fiscal
 18 year after September 15, 1997, for costs incurred by the
 19 Black Lung Disability Trust Fund in the current fiscal
 20 year, such sums as may be necessary.

21 PROGRAM ADMINISTRATION

22 For expenses of administering employment and train-
 23 ing programs and for carrying out section 908 of the So-
 24 cial Security Act, \$81,393,000, together with not to ex-
 25 ceed \$39,977,000, which may be expended from the Em-

1 ployment Security Administration account in the Unem-
2 ployment Trust Fund.

3 PENSION AND WELFARE BENEFITS ADMINISTRATION

4 SALARIES AND EXPENSES

5 For necessary expenses for Pension and Welfare Ben-
6 efits Administration, \$65,783,000.

7 PENSION BENEFIT GUARANTY CORPORATION

8 PENSION BENEFIT GUARANTY CORPORATION FUND

9 The Pension Benefit Guaranty Corporation is author-
10 ized to make such expenditures, including financial assist-
11 ance authorized by section 104 of Public Law 96-364,
12 within limits of funds and borrowing authority available
13 to such Corporation, and in accord with law, and to make
14 such contracts and commitments without regard to fiscal
15 year limitations as provided by section 104 of the Govern-
16 ment Corporation Control Act, as amended (31 U.S.C.
17 9104), as may be necessary in carrying out the program
18 through September 30, 1997, for such Corporation: *Pro-*
19 *vided*, That not to exceed \$135,720,000 shall be available
20 for administrative expenses of the Corporation.

21 EMPLOYMENT STANDARDS ADMINISTRATION

22 SALARIES AND EXPENSES

23 For necessary expenses for the Employment Stand-
24 ards Administration, including reimbursement to State,
25 Federal, and local agencies and their employees for inspec-

1 tion services rendered, \$258,422,000, together with
2 \$983,000 which may be expended from the Special Fund
3 in accordance with sections 39(c) and 44(j) of the
4 Longshore and Harbor Workers' Compensation Act: *Pro-*
5 *vided*, That the Secretary of Labor is authorized to accept,
6 retain, and spend, until expended, in the name of the De-
7 partment of Labor, all sums of money ordered to be paid
8 to the Secretary of Labor, in accordance with the terms
9 of the Consent Judgment in Civil Action No. 91-0027 of
10 the United States District Court for the District of the
11 Northern Mariana Islands (May 21, 1992): *Provided fur-*
12 *ther*, That the Secretary of Labor is authorized to estab-
13 lish and, in accordance with 31 U.S.C. 3302, collect and
14 deposit in the Treasury fees for processing applications
15 and issuing certificates under sections 11(d) and 14 of the
16 Fair Labor Standards Act of 1938, as amended (29
17 U.S.C. 211(d) and 214) and for processing applications
18 and issuing registrations under Title I of the Migrant and
19 Seasonal Agricultural Worker Protection Act, 29 U.S.C.
20 1801 et seq.

21 SPECIAL BENEFITS

22 (INCLUDING TRANSFER OF FUNDS)

23 For the payment of compensation, benefits, and ex-
24 penses (except administrative expenses) accruing during
25 the current or any prior fiscal year authorized by title 5,
26 chapter 81 of the United States Code; continuation of ben-

1 efits as provided for under the head “Civilian War Bene-
2 fits” in the Federal Security Agency Appropriation Act,
3 1947; the Employees’ Compensation Commission Appro-
4 priation Act, 1944; and sections 4(c) and 5(f) of the War
5 Claims Act of 1948 (50 U.S.C. App. 2012); and 50 per
6 centum of the additional compensation and benefits re-
7 quired by section 10(h) of the Longshore and Harbor
8 Workers’ Compensation Act, as amended, \$213,000,000
9 together with such amounts as may be necessary to be
10 charged to the subsequent year appropriation for the pay-
11 ment of compensation and other benefits for any period
12 subsequent to August 15 of the current year: *Provided*,
13 That such sums as are necessary may be used under sec-
14 tion 8104 of title 5, United States Code, by the Secretary
15 to reimburse an employer, who is not the employer at the
16 time of injury, for portions of the salary of a reemployed,
17 disabled beneficiary: *Provided further*, That balances of re-
18 imbursements unobligated on September 30, 1996, shall
19 remain available until expended for the payment of com-
20 pensation, benefits, and expenses: *Provided further*, That
21 in addition there shall be transferred to this appropriation
22 from the Postal Service and from any other corporation
23 or instrumentality required under section 8147(c) of title
24 5, United States Code, to pay an amount for its fair share
25 of the cost of administration, such sums as the Secretary

1 of Labor determines to be the cost of administration for
2 employees of such fair share entities through September
3 30, 1997: *Provided further*, That of those funds trans-
4 ferred to this account from the fair share entities to pay
5 the cost of administration, \$11,390,000 shall be made
6 available to the Secretary of Labor for expenditures relat-
7 ing to capital improvements in support of Federal Employ-
8 ees' Compensation Act administration, and the balance of
9 such funds shall be paid into the Treasury as miscellane-
10 ous receipts: *Provided further*, That the Secretary may re-
11 quire that any person filing a notice of injury or a claim
12 for benefits under Subchapter 5, U.S.C., chapter 81, or
13 under subchapter 33, U.S.C. 901, et seq. (the Longshore
14 and Harbor Workers' Compensation Act, as amended),
15 provide as part of such notice and claim, such identifying
16 information (including Social Security account number) as
17 such regulations may prescribe.

18 BLACK LUNG DISABILITY TRUST FUND

19 (INCLUDING TRANSFER OF FUNDS)

20 For payments from the Black Lung Disability Trust
21 Fund, \$1,007,644,000, of which \$961,665,000 shall be
22 available until September 30, 1998, for payment of all
23 benefits as authorized by section 9501(d) (1), (2), (4), and
24 (7) of the Internal Revenue Code of 1954, as amended,
25 and interest on advances as authorized by section
26 9501(e)(2) of that Act, and of which \$26,071,000 shall

1 be available for transfer to Employment Standards Ad-
2 ministration, Salaries and Expenses, \$19,621,000 for
3 transfer to Departmental Management, Salaries and Ex-
4 penses, and \$287,000 for transfer to Departmental Man-
5 agement, Office of Inspector General, for expenses of oper-
6 ation and administration of the Black Lung Benefits pro-
7 gram as authorized by section 9501(d)(5)(A) of that Act:
8 *Provided, That*, in addition, such amounts as may be nec-
9 essary may be charged to the subsequent year appropria-
10 tion for the payment of compensation, interest, or other
11 benefits for any period subsequent to August 15 of the
12 current year: *Provided further*, That in addition such
13 amounts shall be paid from this fund into miscellaneous
14 receipts as the Secretary of the Treasury determines to
15 be the administrative expenses of the Department of the
16 Treasury for administering the fund during the current
17 fiscal year, as authorized by section 9501(d)(5)(B) of that
18 Act.

19 OCCUPATIONAL SAFETY AND HEALTH ADMINISTRATION
20 SALARIES AND EXPENSES

21 For necessary expenses for the Occupational Safety
22 and Health Administration, \$297,734,000, including not
23 to exceed \$66,929,000 which shall be the maximum
24 amount available for grants to States under section 23(g)
25 of the Occupational Safety and Health Act, which grants

1 shall be no less than fifty percent of the costs of State
2 occupational safety and health programs required to be
3 incurred under plans approved by the Secretary under sec-
4 tion 18 of the Occupational Safety and Health Act of
5 1970; and, in addition, notwithstanding 31 U.S.C. 3302,
6 the Occupational Safety and Health Administration may
7 retain up to \$750,000 per fiscal year of training institute
8 course tuition fees, otherwise authorized by law to be col-
9 lected, and may utilize such sums for occupational safety
10 and health training and education grants: *Provided*, That
11 none of the funds appropriated under this paragraph shall
12 be obligated or expended to prescribe, issue, administer,
13 or enforce any standard, rule, regulation, or order under
14 the Occupational Safety and Health Act of 1970 which
15 is applicable to any person who is engaged in a farming
16 operation which does not maintain a temporary labor
17 camp and employs ten or fewer employees: *Provided fur-*
18 *ther*, That no funds appropriated under this paragraph
19 shall be obligated or expended to administer or enforce
20 any standard, rule, regulation, or order under the Occupa-
21 tional Safety and Health Act of 1970 with respect to any
22 employer of ten or fewer employees who is included within
23 a category having an occupational injury lost workday case
24 rate, at the most precise Standard Industrial Classifica-
25 tion Code for which such data are published, less than the

1 national average rate as such rates are most recently pub-
2 lished by the Secretary, acting through the Bureau of
3 Labor Statistics, in accordance with section 24 of that Act
4 (29 U.S.C. 673), except—

5 (1) to provide, as authorized by such Act, con-
6 sultation, technical assistance, educational and train-
7 ing services, and to conduct surveys and studies;

8 (2) to conduct an inspection or investigation in
9 response to an employee complaint, to issue a cita-
10 tion for violations found during such inspection, and
11 to assess a penalty for violations which are not cor-
12 rected within a reasonable abatement period and for
13 any willful violations found;

14 (3) to take any action authorized by such Act
15 with respect to imminent dangers;

16 (4) to take any action authorized by such Act
17 with respect to health hazards;

18 (5) to take any action authorized by such Act
19 with respect to a report of an employment accident
20 which is fatal to one or more employees or which re-
21 sults in hospitalization of two or more employees,
22 and to take any action pursuant to such investiga-
23 tion authorized by such Act; and

1 (6) to take any action authorized by such Act
2 with respect to complaints of discrimination against
3 employees for exercising rights under such Act:

4 *Provided further*, That the foregoing proviso shall not
5 apply to any person who is engaged in a farming operation
6 which does not maintain a temporary labor camp and em-
7 ploys ten or fewer employees.

8 MINE SAFETY AND HEALTH ADMINISTRATION

9 SALARIES AND EXPENSES

10 For necessary expenses for the Mine Safety and
11 Health Administration, \$191,810,000, including purchase
12 and bestowal of certificates and trophies in connection
13 with mine rescue and first-aid work, and the hire of pas-
14 senger motor vehicles; the Secretary is authorized to ac-
15 cept lands, buildings, equipment, and other contributions
16 from public and private sources and to prosecute projects
17 in cooperation with other agencies, Federal, State, or pri-
18 vate; the Mine Safety and Health Administration is au-
19 thorized to promote health and safety education and train-
20 ing in the mining community through cooperative pro-
21 grams with States, industry, and safety associations; and
22 any funds available to the Department may be used, with
23 the approval of the Secretary, to provide for the costs of
24 mine rescue and survival operations in the event of a
25 major disaster: *Provided*, That none of the funds appro-

1 priated under this paragraph shall be obligated or ex-
2 pended to carry out section 115 of the Federal Mine Safe-
3 ty and Health Act of 1977 or to carry out that portion
4 of section 104(g)(1) of such Act relating to the enforce-
5 ment of any training requirements, with respect to shell
6 dredging, or with respect to any sand, gravel, surface
7 stone, surface clay, colloidal phosphate, or surface lime-
8 stone mine.

9 BUREAU OF LABOR STATISTICS

10 SALARIES AND EXPENSES

11 For necessary expenses for the Bureau of Labor Sta-
12 tistics, including advances or reimbursements to State,
13 Federal, and local agencies and their employees for serv-
14 ices rendered, \$302,947,000, of which \$16,145,000 shall
15 be for expenses of revising the Consumer Price Index and
16 shall remain available until September 30, 1998, together
17 with not to exceed \$52,053,000, which may be expended
18 from the Employment Security Administration account in
19 the Unemployment Trust Fund.

20 DEPARTMENTAL MANAGEMENT

21 SALARIES AND EXPENSES

22 For necessary expenses for Departmental Manage-
23 ment, including the hire of three sedans, and including
24 up to \$4,271,000 for the President's Committee on Em-
25 ployment of People With Disabilities, \$137,504,000; to-

1 gether with not to exceed \$297,000, which may be ex-
2 pended from the Employment Security Administration ac-
3 count in the Unemployment Trust Fund: *Provided*, That
4 no funds made available by this Act may be used by the
5 Solicitor of Labor to participate in a review in any United
6 States court of appeals of any decision made by the Bene-
7 fits Review Board under section 21 of the Longshore and
8 Harbor Workers' Compensation Act (33 U.S.C. 921)
9 where such participation is precluded by the decision of
10 the United States Supreme Court in *Director, Office of*
11 *Workers' Compensation Programs v. Newport News Ship-*
12 *building*, 115 S. Ct. 1278 (1995).

13 ASSISTANT SECRETARY FOR VETERANS EMPLOYMENT
14 AND TRAINING

15 Not to exceed \$178,149,000 may be derived from the
16 Employment Security Administration account in the Un-
17 employment Trust Fund to carry out the provisions of 38
18 U.S.C. 4100–4110A and 4321–4327, and Public Law
19 103–353, and which shall be available for obligation by
20 the States through December 31, 1997.

21 OFFICE OF INSPECTOR GENERAL

22 For salaries and expenses of the Office of Inspector
23 General in carrying out the provisions of the Inspector
24 General Act of 1978, as amended, \$42,938,000, together
25 with not to exceed \$3,543,000, which may be expended

1 from the Employment Security Administration account in
2 the Unemployment Trust Fund.

3 GENERAL PROVISIONS

4 SEC. 101. None of the funds appropriated in this title
5 for the Job Corps shall be used to pay the compensation
6 of an individual, either as direct costs or any proration
7 as an indirect cost, at a rate in excess of \$125,000.

8 SEC. 102. None of the funds made available in this
9 Act may be used by the Occupational Safety and Health
10 Administration directly or through section 23(g) of the
11 Occupational Safety and Health Act for the development,
12 promulgation or issuance of any proposed or final stand-
13 ard or guideline regarding ergonomic protection or record-
14 ing and reporting occupational injuries and illnesses di-
15 rectly related thereto.

16 (TRANSFER OF FUNDS)

17 SEC. 103. Not to exceed 1 percent of any discre-
18 tionary funds (pursuant to the Balanced Budget and
19 Emergency Deficit Control Act, as amended) which are
20 appropriated for the current fiscal year for the Depart-
21 ment of Labor in this Act may be transferred between ap-
22 propriations, but no such appropriation shall be increased
23 by more than 3 percent by any such transfer: *Provided,*
24 That the Appropriations Committees of both Houses of
25 Congress are notified at least fifteen days in advance of
26 any transfer.

1 SEC. 104. Funds shall be available for carrying out
2 title IV–B of the Job Training Partnership Act, notwith-
3 standing section 427(c) of that Act, if a Job Corps center
4 fails to meet national performance standards established
5 by the Secretary.

6 SEC. 105. No funds appropriated or otherwise made
7 available in this title shall be disbursed without the ap-
8 proval of the Department’s Chief Financial Officer or his
9 delegatee.

10 SEC. 106. (a) GENERAL RULE.—In the administra-
11 tion and enforcement of the child labor provisions of the
12 Fair Labor Standards Act of 1938, employees who are 16
13 and 17 years of age shall be permitted to load materials,
14 but not operate or unload materials, into scrap paper
15 balers and paper box compactors—

16 (1) that are safe for 16- and 17-year-old em-
17 ployees loading the scrap paper balers or paper box
18 compactors, and

19 (2) that cannot operate while being loaded.

20 (b) DEFINITION.—For purposes of subsection (a),
21 scrap paper balers and paper box compactors shall be con-
22 sidered safe for 16- or 17-year-old employees to load only
23 if—

24 (1) such scrap paper balers and paper box com-
25 pactors are in compliance with the current safety

1 standard established by the American National
2 Standards Institute;

3 (2) such scrap paper balers and paper box com-
4 pactors include an on-off switch incorporating a
5 keylock or other system and the control of such sys-
6 tem is maintained in the custody of employees who
7 are 18 years of age or older;

8 (3) the on-off switch of such scrap paper balers
9 and paper box compactors is maintained in an off
10 condition when such scrap paper balers and paper
11 box compactors are not in operation; and

12 (4) the employer of 16- and 17-year-old employ-
13 ees provides notice, and posts a notice, on such
14 scrap paper balers and paper box compactors stating
15 that—

16 (A) such scrap paper balers and paper box
17 compactors meet the current safety standard
18 established by the American National Stand-
19 ards Institute;

20 (B) 16- and 17-year-old employees may
21 only load such scrap paper balers and paper
22 box compactors; and

23 (C) any employee under the age of 18 may
24 not operate or unload such scrap paper balers
25 and paper box compactors:

1 *Provided*, That this section is not to be construed as af-
 2 fecting the exemption for apprentices and student learners
 3 published at 29 Code of Federal Regulations 570.63.

4 SEC. 107. None of the funds appropriated in this Act
 5 may be obligated or expended by the Department of Labor
 6 for the purposes of enforcement and the issuance of fines
 7 under Hazardous Occupation Order Number 2 (HO 2)
 8 with respect to incidental and occasional driving by minors

5 General in carrying out the provisions of the Inspector
6 General Act of 1978, as amended, \$29,399,000, together
7 with any funds, to remain available until expended, that
8 represent the equitable share from the forfeiture of prop-
9 erty in investigations in which the Office of Inspector Gen-
10 eral participated, and which are transferred to the Office
11 of the Inspector General by the Department of Justice,
12 the Department of the Treasury, or the United States
13 Postal Service.

14 OFFICE FOR CIVIL RIGHTS

15 For expenses necessary for the Office for Civil
16 Rights, \$16,066,000, together with not to exceed
17 \$3,314,000, to be transferred and expended as authorized
18 by section 201(g)(1) of the Social Security Act from the
19 Hospital Insurance Trust Fund and the Supplemental
20 Medical Insurance Trust Fund.

21 POLICY RESEARCH

22 For carrying out, to the extent not otherwise pro-
23 vided, research studies under section 1110 of the Social
24 Security Act, \$9,000,000.

GENERAL PROVISIONS

1

2 SEC. 201. Funds appropriated in this title shall be
3 available for not to exceed \$37,000 for official reception
4 and representation expenses when specifically approved by
5 the Secretary.

6 SEC. 202. The Secretary shall make available through
7 assignment not more than 60 employees of the Public
8 Health Service to assist in child survival activities and to
9 work in AIDS programs through and with funds provided
10 by the Agency for International Development, the United
11 Nations International Children's Emergency Fund or the
12 World Health Organization.

13 SEC. 203. None of the funds appropriated under this
14 Act may be used to implement section 399L(b) of the Pub-
15 lic Health Service Act or section 1503 of the National In-
16 stitutes of Health Revitalization Act of 1993, Public Law
17 103-43.

18 SEC. 204. None of the funds made available by this
19 Act may be used to withhold payment to any State under
20 the Child Abuse Prevention and Treatment Act by reason
21 of a determination that the State is not in compliance with
22 section 1340.2(d)(2)(ii) of title 45 of the Code of Federal
23 Regulations. This provision expires upon the date of enact-
24 ment of the reauthorization of the Child Abuse Prevention
25 and Treatment Act.

1 SEC. 205. None of the funds appropriated in this Act
2 for the National Institutes of Health and the Substance
3 Abuse and Mental Health Services Administration shall
4 be used to pay the salary of an individual, through a grant
5 or other extramural mechanism, at a rate in excess of
6 \$125,000 per year.

7 SEC. 206. None of the funds appropriated in this Act
8 may be expended pursuant to section 241 of the Public
9 Health Service Act, except for funds specifically provided
10 for in this Act, or for other taps and assessments made
11 by any office located in the Department of Health and
12 Human Services, prior to the Secretary's preparation and
13 submission of a report to the Committee on Appropria-
14 tions of the Senate and of the House detailing the planned
15 uses of such funds.

16 (TRANSFER OF FUNDS)

17 SEC. 207. Of the funds appropriated or otherwise
18 made available for the Department of Health and Human
19 Services, General Departmental Management, for fiscal
20 year 1997, the Secretary of Health and Human Services
21 shall transfer to the Office of the Inspector General such
22 sums as may be necessary for any expenses with respect
23 to the provision of security protection for the Secretary
24 of Health and Human Services.

25 SEC. 208. None of the funds appropriated in this Act
26 may be obligated or expended for the Federal Council on

1 Aging under the Older Americans Act or the Advisory
2 Board on Child Abuse and Neglect under the Child Abuse
3 Prevention and Treatment Act.

4 (TRANSFER OF FUNDS)

5 SEC. 209. Not to exceed 1 percent of any discre-
6 tionary funds (pursuant to the Balanced Budget and
7 Emergency Deficit Control Act, as amended) which are
8 appropriated for the current fiscal year for the Depart-
9 ment of Health and Human Services in this Act may be
10 transferred between appropriations, but no such appro-
11 priation shall be increased by more than 3 percent by any
12 such transfer: *Provided*, That the Appropriations Commit-
13 tees of both Houses of Congress are notified at least fif-
14 teen days in advance of any transfer.

15 (TRANSFER OF FUNDS)

16 SEC. 210. The Director of the National Institutes of
17 Health, jointly with the Director of the Office of AIDS
18 Research, may transfer up to 3 percent among institutes,
19 centers, and divisions from the total amounts identified
20 by these two Directors as funding for research pertaining
21 to the human immunodeficiency virus: *Provided*, That the
22 Congress is promptly notified of the transfer.

23 SEC. 211. None of the funds made available in this
24 Act may be used by the National Institutes of Health to
25 provide grants or cooperative agreements under the SBIR
26 program under section 9(f) of Public Law 85-536 for re-

1 search proposals when it is made known to the Federal
2 official having authority to obligate or expend such funds
3 that (in the process of technical and scientific peer review
4 under section 492 of the Public Health Service Act) the
5 median of the evaluation scores for the proposals in the
6 review cycle involved is higher than the median of the eval-
7 uation scores in such review cycle for RO1 proposals.

8 SEC. 212. EXTENSION OF MORATORIUM.—Section
9 6408(a)(3) of the Omnibus Budget Reconciliation Act of
10 1989, as amended by section 13642 of the Omnibus Budg-
11 et Reconciliation Act of 1993, is amended by striking “De-
12 cember 31, 1995” and inserting “December 31, 2000, or
13 the first day of the first quarter on which the Medigrant
14 plan for the State of Michigan is effective under title XIX
15 of such Act.”.

16 SEC. 213. (a) The Secretary of Health and Human
17 Services may in accordance with this section provide for
18 the relocation of the Federal facility known as the Gillis
19 W. Long Hansen’s Disease Center (located in the vicinity
20 of Carville, in the State of Louisiana), including the relo-
21 cation of the patients of the Center.

22 (b)(1) Subject to entering into a contract in accord-
23 ance with subsection (c), in relocating the Center the Sec-
24 retary may on behalf of the United States transfer to the
25 State of Louisiana, without charge, title to the real prop-

1 erty and improvements that (as of the date of the enact-
2 ment of this Act) constitute the Center. Such real property
3 is a parcel consisting of approximately 330 acres. The
4 exact acreage and legal description used for purposes of
5 the transfer shall be in accordance with a survey satisfac-
6 tory to the Secretary.

7 (2) Any conveyance under paragraph (1) is not effec-
8 tive unless the conveyance specifies that, if the State of
9 Louisiana engages in a material breach of the contract
10 under subsection (c), title to the real property and im-
11 provements involved reverts to the United States at the
12 election of the Secretary.

13 (c) The transfer described in subsection (b) may be
14 made only if, before the transfer is made, the Secretary
15 and the State enter into a contract whose provisions are
16 in accordance with the following:

17 (1) During the 30-year period beginning on the
18 date on which the transfer is made, the real property
19 and improvements referred to in subsection (b) (re-
20 ferred to in this subsection as the “transferred prop-
21 erty”) will be used exclusively for purposes that pro-
22 mote the health or education of the public, with such
23 incidental exceptions as the Secretary may approve,
24 and consistent with the memorandum of understand-

1 ing signed June 11, 1996 by the Chancellors of Lou-
2 isiana State University and Southern University.

3 (2) For purposes of monitoring the extent to
4 which the transferred property is being used in ac-
5 cordance with paragraph (1), the Secretary will have
6 access to such documents as the Secretary deter-
7 mines to be necessary, and the Secretary may re-
8 quire the advance approval of the Secretary for such
9 contracts, conveyances of real or personal property,
10 or other transactions as the Secretary determines to
11 be necessary.

12 (3) The relocation of patients from the trans-
13 ferred property will be completed not later than 3
14 years after the date on the transfer is made, except
15 to the extent the Secretary determines that relocat-
16 ing particular patients is not feasible. During the pe-
17 riod of relocation, the Secretary will have unre-
18 stricted access to the transferred property, and after
19 such period will have such access as may be nec-
20 essary with respect to the patients who pursuant to
21 the preceding sentence are not relocated.

22 (4) The Secretary will provide for the continu-
23 ation at the transferred property of the projects (un-
24 derway as of the date of the enactment of this Act)
25 to make repairs and to make energy-related improve-

1 ments, subject to the availability of appropriations to
2 carry out the projects.

3 (5) The contract disposes of issues regarding
4 access to the cemetery located on the transferred
5 property, and the establishment of a museum re-
6 garding memorabilia relating to the use of the prop-
7 erty to care for patients with Hansen's disease.

8 (6) In the case of each individual who as of the
9 date of the enactment of this Act is a Federal em-
10 ployee at the transferred property with management,
11 engineering, or dietary duties:

12 (A) The State will provide the individual
13 with the right of first refusal to an employment
14 position with the State with substantially the
15 same type of duties as the individual performed
16 in his or her most recent position at the trans-
17 ferred property.

18 (B) If the individual becomes an employee
19 of the State pursuant to subparagraph (A), the
20 State will make payments in accordance with
21 subsection (d)(3)(B) (relating to disability), as
22 applicable with respect to the individual.

23 (7) The contract contains such additional provi-
24 sions as the Secretary determines to be necessary to
25 protect the interests of the United States, and the

1 Secretary shall have final approval over the terms of
2 the contract.

3 (d)(1) This subsection applies if the transfer under
4 subsection (b) is made.

5 (2) In the case of each individual who as of the date
6 of the enactment of this Act is a Federal employee with
7 a position at the Center and is, for duty at the Center,
8 receiving the pay differential under section 5545(d) of title
9 5, United States Code:

10 (A) If as of the date of the transfer under sub-
11 section (b) the individual is eligible for an annuity
12 under section 8336 or 8412 of title 5, United States
13 Code, then once the individual separates from the
14 service and thereby becomes entitled to receive the
15 annuity, the pay differential shall be excluded from
16 the computation of the annuity unless the individual
17 separated from the service not later than 30 days
18 after the date on which the transfer was made.

19 (B) If the individual is not eligible for such an
20 annuity as of the date of the transfer under sub-
21 section (b) but subsequently does become eligible,
22 then once the individual separates from the service
23 and thereby becomes entitled to receive the annuity,
24 the pay differential shall be excluded from the com-
25 putation of the annuity unless the individual sepa-

1 rated from the service not later than 30 days after
2 the date on which the individual first became eligible
3 for the annuity.

4 (C) For purposes of this paragraph, the individ-
5 ual is eligible for the annuity if the individual meets
6 all conditions under such section 8336 or 8412 to be
7 entitled to the annuity, except the condition that the
8 individual be separated from the service.

9 (3) In the case of each individual who as of the date
10 of the enactment of this Act is a Federal employee at the
11 Center with management, engineering, or dietary duties,
12 and who becomes an employee of the State pursuant to
13 subsection (e)(6)(A):

14 (A) The provisions of subchapter III of chapter
15 83 of title 5, United States Code, or of chapter 84
16 of such title, whichever is applicable, that relate to
17 disability shall be considered to remain in effect with
18 respect to the individual (subject to subparagraph
19 (C)) until the earlier of—

20 (i) the expiration of the 2-year period be-
21 ginning on the date on which the transfer under
22 subsection (b) is made; or

23 (ii) the date on which the individual first
24 meets all conditions for coverage under a State

1 program for payments during retirement by
2 reason of disability.

3 (B) The payments to be made by a State pur-
4 suant to subsection (c)(6)(B) with respect to the in-
5 dividual are payments to the Civil Service Retire-
6 ment and Disability Fund, if the individual is receiv-
7 ing Federal disability coverage pursuant to subpara-
8 graph (A). Such payments are to be made in a total
9 amount equal to that portion of the normal-cost per-
10 centage (determined through the use of dynamic as-
11 sumptions) of the basic pay of the individual that is
12 allocable to such coverage and is paid for service
13 performed during the period for which such coverage
14 is in effect. Such amount is to be determined in ac-
15 cordance with chapter 84 of such title 5, is to be
16 paid at such time and in such manner as mutually
17 agreed by the State and the Office of Personnel
18 Management, and is in lieu of individual or agency
19 contributions otherwise required.

20 (C) In the determination pursuant to subpara-
21 graph (A) of whether the individual is eligible for
22 Federal disability coverage (during the applicable pe-
23 riod of time under such subparagraph), service as an
24 employee of the State after the date of the transfer
25 under subsection (b) shall be counted toward the

1 service requirement specified in the first sentence of
2 section 8337(a) or 8451(a)(1)(A) of such title 5
3 (whichever is applicable).

4 (e) The following provisions apply if under subsection
5 (a) the Secretary makes the decision to relocate the Cen-
6 ter:

7 (1) The site to which the Center is relocated
8 shall be in the vicinity of Baton Rouge, in the State
9 of Louisiana.

10 (2) The facility involved shall continue to be
11 designated as the Gillis W. Long Hansens's Disease
12 Center.

13 (3) The Secretary shall make reasonable efforts
14 to inform the patients of the Center with respect to
15 the planning and carrying out of the relocation.

16 (4) In the case of each individual who as of Oc-
17 tober 1, 1996, is a patient of the Center and is re-
18 ceiving long-term care (referred to in this subsection
19 as an "eligible patient"), the Secretary shall con-
20 tinue to provide for the long-term care of the eligible
21 patient, without charge, for the remainder of the life
22 of the patient. Of the amounts appropriated for a
23 fiscal year for the Public Health Service, the Sec-
24 retary shall make available such amounts as may be
25 necessary to carry out the preceding sentence.

1 (5) Except in the case of an eligible patient for
2 whom it is not feasible to relocate for purposes of
3 subsection (c)(3), each eligible patient may make an
4 irrevocable choice of one of the following long-term
5 care options:

6 (A) For the remainder of his or her life,
7 the patient may reside at the Center.

8 (B) For the remainder of his or her life,
9 the patient may elect to receive payments each
10 year in an annual amount of \$33,000 (adjusted
11 for fiscal year 1998 and each subsequent fiscal
12 year to the extent necessary to offset inflation
13 occurring after October 1, 1996), which pay-
14 ments are in complete discharge of the obliga-
15 tion of the Federal Government under para-
16 graph (4). If the individual makes the election
17 under the preceding sentence, the Federal Gov-
18 ernment does not under such paragraph have
19 any responsibilities regarding the daily life of
20 the patient, other than making such payments.

21 (6) The Secretary shall provide to each eligible
22 patient such information and time as may be nec-
23 essary for the patient to make an informed decision
24 regarding the options under paragraph (5).

25 (f) For purposes of this section:

1 (1) The term “Center” means the Gillis W.
2 Long Hansen’s Disease Center.

3 (2) The term “Secretary” means the Secretary
4 of Health and Human Services.

5 (3) The term “State” means the State of Lou-
6 isiana.

7 (g) Section 320 of the Public Health Service Act (42
8 U.S.C. 247e) is amended by striking the section designa-
9 tion and all that follows and inserting the following:

10 “SEC. 320. (a)(1) At the Gillis W. Long Hansen’s
11 Disease Center (located in the State of Louisiana), the
12 Secretary shall without charge provide short-term care
13 and treatment, including outpatient care, for Hansen’s
14 disease and related complications to any person deter-
15 mined by the Secretary to be in need of such care and
16 treatment.

17 “(2) The Center referred to in paragraph (1) shall
18 conduct training in the diagnosis and management of
19 Hansen’s disease and conduct and promote the coordina-
20 tion of research, investigations, demonstrations, and stud-
21 ies relating to the causes, diagnosis, treatment, control,
22 and prevention of Hansen’s disease and the complications
23 of such disease.

1 “(3) Paragraph (1) is subject to section 213 of the
2 Department of Health and Human Services Appropria-
3 tions Act, 1997.

4 “(b) In addition to the Center referred to in sub-
5 section (a), the Secretary may establish sites regarding
6 persons with Hansen’s disease. Each such site shall pro-
7 vide for the outpatient care and treatment for Hansen’s
8 disease to any person determined by the Secretary to be
9 in need of such care and treatment.

10 “(c) The Secretary shall make payments to the Board
11 of Health of the State of Hawaii for the care and treat-
12 ment (including outpatient care) in its facilities of persons
13 suffering from Hansen’s disease at a rate determined by
14 the Secretary. The rate shall be approximately equal to
15 the operating cost per patient of such facilities, except that
16 the rate may not exceed the comparable costs per patient
17 with Hansen’s disease for care and treatment provided by
18 the Center referred to in subsection (a). Payments under
19 this subsection are subject to the availability of appropria-
20 tions for such purpose.”.

21 SEC. 214. (a) None of the funds made available in
22 this Act or any other Act may be used to make any award
23 of a grant or contract under section 1001 of title X of
24 the Public Health Service Act for fiscal year 1997 or any
25 subsequent fiscal year unless the applicant for the award

1 agrees that, in operating the voluntary family planning
2 project involved, the applicant will comply with the follow-
3 ing conditions:

4 (1) Priority will be given in the project to the
5 provision of services to individuals from low-income
6 families.

7 (2) An individual will not be charged for serv-
8 ices in the project if the family of the individual has
9 a total annual income that is at or below 100 per-
10 cent of the Federal poverty line, except to the extent
11 that payment will be made by a third party (includ-
12 ing a government agency) that is authorized, or is
13 under a legal obligation, to pay the charge.

14 (3) If the family of the individual has a total
15 annual income that exceeds 100 percent of such pov-
16 erty line but does not exceed 250 percent of the line,
17 the project will impose a charge according to the
18 ability to pay.

19 (4) If the family of the individual has a total
20 annual income that exceeds 250 percent of such pov-
21 erty line, the project will impose the full charge for
22 the services involved.

23 (5) Subject to paragraphs (1) through (4), the
24 policies of the applicant will ensure that economic

1 status is not a deterrent to participation in the
2 project.

3 (b) None of the funds made available in this Act may
4 be expended for the program under section 1001 of title
5 X of the Public Health Service Act after the expiration
6 of the 180-day period beginning on the date of the enact-
7 ment of this Act unless the Secretary of Health and
8 Human Services submits to the Congress, not later than
9 such date of expiration, a report providing, to the extent
10 that the information is available to the Secretary, the fol-
11 lowing information for the most recent fiscal year for
12 which the information is available:

13 (1) The number of individuals who receive fam-
14 ily planning services through voluntary family plan-
15 ning projects under such section 1001, and the de-
16 mographic characteristics of the individuals.

17 (2) The types of family planning services cho-
18 sen by recipients of services from such projects.

19 (3) The number of individuals served by such
20 projects who are—

21 (A) at risk of unintended pregnancy; and

22 (B) from a family with a total annual in-
23 come not exceeding 250 percent.

24 (4) The extent to which the availability of fam-
25 ily planning services from such projects has, among

1 individuals served by the projects, reduced the num-
2 ber of unintended pregnancies, reduced the number
3 of abortions, and reduced the number of cases of
4 sexually transmitted diseases.

5 (5) The extent to which the availability of fam-
6 ily planning services from such projects has reduced
7 Federal and State expenditures for—

8 (A) the program under title XIX of the So-
9 cial Security Act (commonly known as the Med-
10 icaid program); and

11 (B) the programs under title IV of such
12 Act (commonly referred to as welfare pro-
13 grams).

14 This title may be cited as the “Department of Health
15 and Human Services Appropriations Act, 1997”.

16 TITLE III—DEPARTMENT OF EDUCATION

17 EDUCATION REFORM

18 For carrying out activities authorized by the School-
19 to-Work Opportunities Act, \$175,000,000, which shall be-
20 come available on July 1, 1997, and remain available
21 through September 30, 1998.

22 EDUCATION FOR THE DISADVANTAGED

23 For carrying out title I of the Elementary and Sec-
24 ondary Education Act of 1965, \$7,204,130,000, of which
25 \$5,895,244,000 shall become available on July 1, 1997,
26 and shall remain available through September 30, 1998,

1 and of which \$1,298,386,000 shall become available on
2 October 1, 1997 and shall remain available through Sep-
3 tember 30, 1998, for academic year 1997–1998: *Provided*,
4 That \$6,042,766,000 shall be available for basic grants
5 under section 1124: *Provided further*, That up to
6 \$3,500,000 of these funds shall be available to the Sec-
7 retary on October 1, 1996, to obtain updated local-edu-
8 cational-agency-level census poverty data from the Bureau
9 of the Census: *Provided further*, That \$684,082,000 shall
10 be available for concentration grants under section
11 1124(A) and \$7,000,000 shall be available for evaluations
12 under section 1501.

13 IMPACT AID

14 For carrying out programs of financial assistance to
15 federally affected schools authorized by title VIII of the
16 Elementary and Secondary Education Act of 1965,
17 \$728,000,000, of which \$615,500,000 shall be for basic
18 support payments under section 8003(b), \$40,000,000
19 shall be for payments for children with disabilities under
20 section 8003(d), \$50,000,000, to remain available until
21 expended, shall be for payments under section 8003(f),
22 \$5,000,000 shall be for construction under section 8007,
23 and \$17,500,000 shall be for Federal property payments
24 under section 8002.

1 SCHOOL IMPROVEMENT PROGRAMS

2 For carrying out school improvement activities au-
3 thorized by titles IV–A–1, V–A, VI, IX, X and XIII of
4 the Elementary and Secondary Education Act of 1965; the
5 Stewart B. McKinney Homeless Assistance Act; and the
6 Civil Rights Act of 1964; \$1,235,383,000 of which
7 \$1,071,495,000 shall become available on July 1, 1997,
8 and remain available through September 30, 1998: *Pro-*
9 *vided*, That of the amount appropriated, \$606,517,000
10 shall be for innovative education program strategies State
11 grants under title VI–A: *Provided further*, That the per-
12 centage of the funds appropriated under this heading for
13 innovative education program strategies State grants that
14 are allocated to any State or territory shall not be less
15 than the percentage allocated to such State or territory
16 from the total of the funds appropriated in appropriation
17 laws for fiscal year 1996 for the combined totals of such
18 grants plus Eisenhower professional development State
19 grants, foreign language assistance grants, and the star
20 schools program.

21 BILINGUAL AND IMMIGRANT EDUCATION

22 For carrying out, to the extent not otherwise pro-
23 vided, bilingual and immigrant education activities author-
24 ized by parts A and C of title VII of the Elementary and
25 Secondary Education Act, without regard to section
26 7103(b), \$167,190,000, of which \$50,000,000 shall be for

1 immigrant education programs authorized by part C: *Pro-*
2 *vided*, That State educational agencies may use all, or any
3 part of, their part C allocation for competitive grants to
4 local educational agencies: *Provided further*, That the De-
5 partment of Education should only support instructional
6 programs which ensure that students completely master
7 English in a timely fashion (a period of three to five years)
8 while meeting rigorous achievement standards in the aca-
9 demic content areas.

10 SPECIAL EDUCATION

11 For carrying out the Individuals with Disabilities
12 Education Act (except part I), \$3,246,315,000, of which
13 \$3,000,000,000 shall become available for obligation on
14 July 1, 1997, and shall remain available through Septem-
15 ber 30, 1998.

16 REHABILITATION SERVICES AND DISABILITY RESEARCH

17 For carrying out, to the extent not otherwise pro-
18 vided, the Rehabilitation Act of 1973, the Technology-
19 related Assistance for Individuals with Disabilities Act, and
20 the Helen Keller National Center Act, as amended,
21 \$2,509,447,000.

22 SPECIAL INSTITUTIONS FOR PERSONS WITH
23 DISABILITIES

24 AMERICAN PRINTING HOUSE FOR THE BLIND

25 For carrying out the Act of March 3, 1879, as
26 amended (20 U.S.C. 101 et seq.), \$6,680,000.

1 NATIONAL TECHNICAL INSTITUTE FOR THE DEAF

2 For the National Technical Institute for the Deaf
3 under titles I and II of the Education of the Deaf Act
4 of 1986 (20 U.S.C. 4301 et seq.), \$43,041,000: *Provided*,
5 That from the amount available, the Institute may at its
6 discretion use funds for the endowment program as au-
7 thorized under section 207.

8 GALLAUDET UNIVERSITY

9 For the Kendall Demonstration Elementary School,
10 the Model Secondary School for the Deaf, and the partial
11 support of Gallaudet University under titles I and II of
12 the Education of the Deaf Act of 1986 (20 U.S.C. 4301
13 et seq.), \$79,182,000: *Provided*, That from the amount
14 available, the University may at its discretion use funds
15 for the endowment program as authorized under section
16 207.

17 VOCATIONAL AND ADULT EDUCATION

18 For carrying out, to the extent not otherwise pro-
19 vided, the Carl D. Perkins Vocational and Applied Tech-
20 nology Education Act and the Adult Education Act,
21 \$1,329,669,000, of which \$1,326,750,000 shall become
22 available on July 1, 1997 and shall remain available
23 through September 30, 1998: *Provided*, That no funds
24 shall be awarded to a State Council under section 112(f)
25 of the Carl D. Perkins Vocational and Applied Technology

1 Education Act, and no State shall be required to operate
2 such a Council.

3 STUDENT FINANCIAL ASSISTANCE

4 For carrying out subparts 1 and 3 of part A, part
5 C and part E of title IV of the Higher Education Act of
6 1965, as amended, \$6,630,407,000, which shall remain
7 available through September 30, 1998.

8 The maximum Pell Grant for which a student shall
9 be eligible during award year 1997–1998 shall be \$2,500:
10 *Provided*, That notwithstanding section 401(g) of the Act,
11 if the Secretary determines, prior to publication of the
12 payment schedule for such award year, that the amount
13 included within this appropriation for Pell Grant awards
14 in such award year, and any funds available from the fis-
15 cal year 1996 appropriation for Pell Grant awards, are
16 insufficient to satisfy fully all such awards for which stu-
17 dents are eligible, as calculated under section 401(b) of
18 the Act, the amount paid for each such award shall be
19 reduced by either a fixed or variable percentage, or by a
20 fixed dollar amount, as determined in accordance with a
21 schedule of reductions established by the Secretary for this
22 purpose.

23 FEDERAL FAMILY EDUCATION LOAN PROGRAM ACCOUNT

24 For Federal administrative expenses to carry out
25 guaranteed student loans authorized by title IV, part B,
26 of the Higher Education Act, as amended, \$29,977,000.

1 HIGHER EDUCATION

2 For carrying out, to the extent not otherwise pro-
3 vided, parts A and B of title III, without regard to section
4 360(a)(1)(B)(ii), titles IV, V, VI, VII, and IX, part A and
5 subpart 1 of part B of title X, and title XI of the Higher
6 Education Act of 1965, as amended, and the Mutual Edu-
7 cational and Cultural Exchange Act of 1961;
8 \$829,497,000, of which \$15,673,000 for interest subsidies
9 under title VII of the Higher Education Act, as amended,
10 shall remain available until expended: *Provided*, That
11 funds available for part D of title IX of the Higher Edu-
12 cation Act shall be available to fund noncompeting con-
13 tinuation awards for academic year 1997–1998 for fellow-
14 ships awarded originally under parts B and C of title IX
15 of said Act, under the terms and conditions of parts B
16 and C, respectively.

17 HOWARD UNIVERSITY

18 For partial support of Howard University (20 U.S.C.
19 121 et seq.), \$187,348,000: *Provided*, That from the
20 amount available, the University may at its discretion use
21 funds for the endowment program as authorized under the
22 Howard University Endowment Act (Public Law 98–480).

23 HIGHER EDUCATION FACILITIES LOANS

24 The Secretary is hereby authorized to make such ex-
25 penditures, within the limits of funds available under this
26 heading and in accord with law, and to make such con-

1 tracts and commitments without regard to fiscal year limi-
 2 tation, as provided by section 104 of the Government Cor-
 3 poration Control Act (31 U.S.C. 9104), as may be nec-
 4 essary in carrying out the program for the current fiscal
 5 year.

6 COLLEGE HOUSING AND ACADEMIC FACILITIES LOANS

7 PROGRAM

8 For administrative expenses to carry out the existing
 9 direct loan program of college housing and academic facili-
 10 ties loans entered into pursuant to title VII, part C, of
 11 the Higher Education Act, as amended, \$698,000.

12 COLLEGE HOUSING LOANS

13 Pursuant to title VII, part C of the Higher Education
 14 Act, as amended, for necessary expenses of the college
 15 housing loans program, the Secretary shall make expendi-
 16 tures and enter into contracts without regard to fiscal year
 17 limitation using loan repayments and other resources
 18 available to this account. Any unobligated balances becom-
 19 ing available from fixed fees paid into this account pursu-
 20 ant to 12 U.S.C. 1749d, relating to payment of costs for
 21 inspections and site visits, shall be available for the operat-

2 in section 502 of the Congressional Budget Act of 1974,
3 of such bonds shall not exceed zero.

4 For administrative expenses to carry out the Histori-
5 cally Black College and University Capital Financing Pro-
6 gram entered into pursuant to title VII, part B of the
7 Higher Education Act, as amended, \$104,000.

8 EDUCATION RESEARCH, STATISTICS, AND IMPROVEMENT

9 For carrying out activities authorized by the Edu-
10 cational Research, Development, Dissemination, and Im-
11 provement Act of 1994; the National Education Statistics
12 Act of 1994; section 2102(c)(11), sections 3136 and 3141,
13 parts A, B, and section 10601 of title X, and part C of
14 title XIII of the Elementary and Secondary Education Act
15 of 1965, as amended, and title VI of Public Law 103–
16 227, \$319,264,000: *Provided*, That \$48,000,000 shall be
17 for sections 3136 and 3141 of the Elementary and Sec-
18 ondary Education Act: *Provided further*, That none of the
19 funds appropriated in this paragraph may be obligated or
20 expended for the Goals 2000 Community Partnerships
21 Program.

22 LIBRARIES

23 For carrying out, to the extent not otherwise pro-
24 vided, titles I, III, and IV of the Library Services and Con-
25 struction Act, and title II–B of the Higher Education Act,
26 \$108,000,000, of which \$2,500,000 shall be for section

1 222 and \$1,000,000 shall be for section 223 of the Higher
2 Education Act.

3 DEPARTMENTAL MANAGEMENT

4 PROGRAM ADMINISTRATION

5 For carrying out, to the extent not otherwise pro-
6 vided, the Department of Education Organization Act, in-
7 cluding rental of conference rooms in the District of Co-
8 lumbia and hire of two passenger motor vehicles,
9 \$320,152,000.

10 OFFICE FOR CIVIL RIGHTS

11 For expenses necessary for the Office for Civil
12 Rights, as authorized by section 203 of the Department
13 of Education Organization Act, \$54,171,000.

14 OFFICE OF THE INSPECTOR GENERAL

15 For expenses necessary for the Office of the Inspector
16 General, as authorized by section 212 of the Department
17 of Education Organization Act, \$27,143,000, together
18 with any funds, to remain available until expended, that
19 represent the equitable share from the forfeiture of prop-
20 erty in investigations in which the Office of Inspector Gen-
21 eral participated, and which are transferred to the Office
22 of the Inspector General by the Department of Justice,
23 the Department of the Treasury, or the United States
24 Postal Service.

1 GENERAL PROVISIONS

2 SEC. 301. No funds appropriated in this Act may be
3 used for the transportation of students or teachers (or for
4 the purchase of equipment for such transportation) in
5 order to overcome racial imbalance in any school or school
6 system, or for the transportation of students or teachers
7 (or for the purchase of equipment for such transportation)
8 in order to carry out a plan of racial desegregation of any
9 school or school system.

10 SEC. 302. None of the funds contained in this Act
11 shall be used to require, directly or indirectly, the trans-
12 portation of any student to a school other than the school
13 which is nearest the student's home, except for a student
14 requiring special education, to the school offering such
15 special education, in order to comply with title VI of the
16 Civil Rights Act of 1964. For the purpose of this section
17 an indirect requirement of transportation of students in-
18 cludes the transportation of students to carry out a plan
19 involving the reorganization of the grade structure of
20 schools, the pairing of schools, or the clustering of schools,
21 or any combination of grade restructuring, pairing or clus-
22 tering. The prohibition described in this section does not
23 include the establishment of magnet schools.

1 SEC. 303. No funds appropriated under this Act may
2 be used to prevent the implementation of programs of vol-
3 untary prayer and meditation in the public schools.

4 SEC. 304. Notwithstanding any other provision of
5 law, funds available under section 458 of the Higher Edu-
6 cation Act shall not exceed \$420,000,000 for fiscal year
7 1997. The Department of Education shall use at least
8 \$134,000,000 for payment of administrative cost allow-
9 ances owed to guaranty agencies for fiscal years 1996 and
10 1997. The Department of Education shall pay administra-
11 tive cost allowances to guaranty agencies, to be paid quar-
12 terly. Receipt of such funds and uses of such funds by
13 guaranty agencies shall be in accordance with section
14 428(f) of the Higher Education Act.

15 Notwithstanding section 458 of the Higher Education
16 Act, the Secretary may not use funds available under that
17 section or any other section for subsequent fiscal years
18 for administrative expenses of the William D. Ford Direct
19 Loan Program. The Secretary may not require the return
20 of guaranty agency reserve funds during fiscal year 1997,
21 except after consultation with both the Chairmen and
22 ranking members of the House Economic and Educational
23 Opportunities Committee and the Senate Labor and
24 Human Resources Committee. Any reserve funds recov-
25 ered by the Secretary shall be returned to the Treasury

1 of the United States for purposes of reducing the Federal
2 deficit.

3 No funds available to the Secretary may be used for
4 (1) the hiring of advertising agencies or other third parties
5 to provide advertising services for student loan programs,
6 or (2) payment of administrative fees relating to the Wil-
7 liam D. Ford Direct Loan Program to institutions of high-
8 er education.

9 SEC. 305. None of the funds appropriated in this Act
10 may be obligated or expended to carry out sections 727,
11 932, and 1002 of the Higher Education Act of 1965, and
12 section 621(b) of Public Law 101–589.

13 (TRANSFER OF FUNDS)

14 SEC. 306. Not to exceed 1 percent of any discre-
15 tionary funds (pursuant to the Balanced Budget and
16 Emergency Deficit Control Act, as amended) which are
17 appropriated for the current fiscal year for the Depart-
18 ment of Education in this Act may be transferred between
19 appropriations, but no such appropriation shall be in-
20 creased by more than 3 percent by any such transfer: *Pro-*
21 *vided*, That the Appropriations Committees of both
22 Houses of Congress are notified at least fifteen days in
23 advance of any transfer.

24 This title may be cited as the “Department of Edu-
25 cation Appropriations Act, 1997”.

1 TITLE IV—RELATED AGENCIES

2 ARMED FORCES RETIREMENT HOME

3 For expenses necessary for the Armed Forces Retire-
4 ment Home to operate and maintain the United States
5 Soldiers' and Airmen's Home and the United States Naval

19 DOMESTIC VOLUNTEER SERVICE PROGRAMS, OPERATING

20 EXPENSES

21 For expenses necessary for the Corporation for Na-
22 tional and Community Service to carry out the provisions
23 of the Domestic Volunteer Service Act of 1973, as amend-
24 ed, \$202,046,000.

1 CORPORATION FOR PUBLIC BROADCASTING

2 For payment to the Corporation for Public Broad-
3 casting, as authorized by the Communications Act of
4 1934, an amount which shall be available within limita-
5 tions specified by that Act, for the fiscal year 1999,
6 \$250,000,000: *Provided*, That no funds made available to
7 the Corporation for Public Broadcasting by this Act shall
8 be used to pay for receptions, parties, or similar forms
9 of entertainment for Government officials or employees:
10 *Provided further*, That none of the funds contained in this
11 paragraph shall be available or used to aid or support any
12 program or activity from which any person is excluded,
13 or is denied benefits, or is discriminated against, on the
14 basis of race, color, national origin, religion, or sex.

15 FEDERAL MEDIATION AND CONCILIATION SERVICE

16 SALARIES AND EXPENSES

17 For expenses necessary for the Federal Mediation
18 and Conciliation Service to carry out the functions vested
19 in it by the Labor Management Relations Act, 1947 (29
20 U.S.C. 171–180, 182–183), including hire of passenger
21 motor vehicles; and for expenses necessary for the Labor-
22 Management Cooperation Act of 1978 (29 U.S.C. 175a);
23 and for expenses necessary for the Service to carry out
24 the functions vested in it by the Civil Service Reform Act,
25 Public Law 95–454 (5 U.S.C. chapter 71), \$32,579,000

1 including \$1,500,000, to remain available through Sep-
2 tember 30, 1998, for activities authorized by the Labor-
3 Management Cooperation Act of 1978 (29 U.S.C. 175a):
4 *Provided*, That notwithstanding 31 U.S.C. 3302, fees
5 charged, up to full-cost recovery, for special training ac-
6 tivities and for arbitration services shall be credited to and
7 merged with this account, and shall remain available until
8 expended: *Provided further*, That fees for arbitration serv-
9 ices shall be available only for education, training, and
10 professional development of the agency workforce: *Pro-*
11 *vided further*, That the Director of the Service is author-
12 ized to accept on behalf of the United States gifts of serv-
13 ices and real, personal, or other property in the aid of any
14 projects or functions within the Director's jurisdiction.

15 FEDERAL MINE SAFETY AND HEALTH REVIEW

16 COMMISSION

17 SALARIES AND EXPENSES

18 For expenses necessary for the Federal Mine Safety
19 and Health Review Commission (30 U.S.C. 801 et seq.),
20 \$6,060,000.

21 NATIONAL COMMISSION ON LIBRARIES AND

22 INFORMATION SCIENCE

23 SALARIES AND EXPENSES

24 For necessary expenses for the National Commission
25 on Libraries and Information Science, established by the

1 Act of July 20, 1970 (Public Law 91–345, as amended
2 by Public Law 102–95), \$812,000.

3 NATIONAL COUNCIL ON DISABILITY

4 SALARIES AND EXPENSES

5 For expenses necessary for the National Council on
6 Disability as authorized by title IV of the Rehabilitation
7 Act of 1973, as amended, \$1,757,000.

8 NATIONAL EDUCATION GOALS PANEL

9 For expenses necessary for the National Education
10 Goals Panel, as authorized by title II, part A of the Goals
11 2000: Educate America Act, \$974,000.

12 NATIONAL LABOR RELATIONS BOARD

13 SALARIES AND EXPENSES

14 For expenses necessary for the National Labor Rela-
15 tions Board to carry out the functions vested in it by the
16 Labor-Management Relations Act, 1947, as amended (29
17 U.S.C. 141–167), and other laws, \$144,692,000: *Pro-*
18 *vided*, That no part of this appropriation shall be available
19 to organize or assist in organizing agricultural laborers or
20 used in connection with investigations, hearings, direc-
21 tives, or orders concerning bargaining units composed of
22 agricultural laborers as referred to in section 2(3) of the
23 Act of July 5, 1935 (29 U.S.C. 152), and as amended
24 by the Labor-Management Relations Act, 1947, as amend-
25 ed, and as defined in section 3(f) of the Act of June 25,

1 1938 (29 U.S.C. 203), and including in said definition em-
2 ployees engaged in the maintenance and operation of
3 ditches, canals, reservoirs, and waterways when main-
4 tained or operated on a mutual, nonprofit basis and at
5 least 95 per centum of the water stored or supplied there-
6 by is used for farming purposes: *Provided further*, That
7 none of the funds made available by this Act shall be used

7 PROSPECTIVE PAYMENT ASSESSMENT COMMISSION

8 SALARIES AND EXPENSES

9 For expenses necessary to carry out section 1886(e)
10 of the Social Security Act, \$3,263,000, to be transferred
11 to this appropriation from the Federal Hospital Insurance
12 and the Federal Supplementary Medical Insurance Trust
13 Funds.

14 SOCIAL SECURITY ADMINISTRATION

15 PAYMENTS TO SOCIAL SECURITY TRUST FUNDS

16 For payment to the Federal Old-Age and Survivors

20 In addition, to reimburse these trust funds for admin-

23 main available until expended.

1 SPECIAL BENEFITS FOR DISABLED COAL MINERS

2 For carrying out title IV of the Federal Mine Safety
3 and Health Act of 1977, \$460,070,000, to remain avail-
4 able until expended.

5 For making, after July 31 of the current fiscal year,
6 benefit payments to individuals under title IV of the Fed-
7 eral Mine Safety and Health Act of 1977, for costs in-
8 curred in the current fiscal year, such amounts as may
9 be necessary.

10 For making benefit payments under title IV of the
11 Federal Mine Safety and Health Act of 1977 for the first
12 quarter of fiscal year 1998, \$160,000,000, to remain
13 available until expended.

14 SUPPLEMENTAL SECURITY INCOME PROGRAM

15 For carrying out titles XI and XVI of the Social Se-
16 curity Act, section 401 of Public Law 92-603, section 212
17 of Public Law 93-66, as amended, and section 405 of
18 Public Law 95-216, including payment to the Social Secu-
19 rity trust funds for administrative expenses incurred pur-

22 *vided*, That any portion of the funds provided to a State

26 September 30, 1998, for continuing disability reviews as

1 authorized by section 103 of Public Law 104–121. The
2 term “continuing disability reviews” has the meaning
3 given such term by section 201(g)(1)(A) of the Social Se-
4 curity Act.

5 For making, after June 15 of the current fiscal year,
6 benefit payments to individuals under title XVI of the So-
7 cial Security Act, for unanticipated costs incurred for the
8 current fiscal year, such sums as may be necessary.

9 For carrying out title XVI of the Social Security Act
10 for the first quarter of fiscal year 1998, \$9,690,000,000,
11 to remain available until expended.

12 LIMITATION ON ADMINISTRATIVE EXPENSES

13 For necessary expenses, including the hire of two pas-
14 senger motor vehicles, and not to exceed \$10,000 for offi-
15 cial reception and representation expenses, not more than
16 \$5,899,797,000 may be expended, as authorized by sec-

3 ing continuing disability reviews.

4 In addition to funding already available under this
5 heading, and subject to the same terms and conditions,
6 \$160,000,000, to remain available until September 30,
7 1998, for continuing disability reviews as authorized by
8 section 103 of Public Law 104–121. The term “continuing
9 disability reviews” has the meaning given such term by
10 section 201(g)(1)(A) of the Social Security Act.

11 In addition to funding already available under this
12 heading, and subject to the same terms and conditions,
13 \$250,073,000, which shall remain available until ex-
14 pended, to invest in a state-of-the-art computing network,
15 including related equipment and administrative expenses
16 associated solely with this network, for the Social Security
17 Administration and the State Disability Determination
18 Services, may be expended from any or all of the trust

22 For expenses necessary for the Office of Inspector
23 General in carrying out the provisions of the Inspector
24 General Act of 1978, as amended, \$6,335,000, together
25 with not to exceed \$21,089,000, to be transferred and ex-
26 pended as authorized by section 201(g)(1) of the Social

1 Security Act from the Federal Old-Age and Survivors In-
2 surance Trust Fund and the Federal Disability Insurance
3 Trust Fund.

4 RAILROAD RETIREMENT BOARD

5 DUAL BENEFITS PAYMENTS ACCOUNT

6 For payment to the Dual Benefits Payments Ac-
7 count, authorized under section 15(d) of the Railroad Re-
8 tirement Act of 1974, \$223,000,000, which shall include
9 amounts becoming available in fiscal year 1997 pursuant
10 to section 224(c)(1)(B) of Public Law 98-76; and in addi-
11 tion, an amount, not to exceed 2 percent of the amount
12 provided herein, shall be available proportional to the
13 amount by which the product of recipients and the average
14 benefit received exceeds \$223,000,000: *Provided*, That the
15 total amount provided herein shall be credited in 12 ap-
16 proximately equal amounts on the first day of each month
17 in the fiscal year.

10 For expenses necessary for the Office of Inspector
11 General for audit, investigatory and review activities, as
12 authorized by the Inspector General Act of 1978, as
13 amended, not more than \$5,268,000, to be derived from
14 the railroad retirement accounts and railroad unemploy-
15 ment insurance account: *Provided*, That none of the funds
16 made available in this Act may be transferred to the Office
17 from the Department of Health and Human Services, or
18 used to carry out any such transfer: *Provided further*, That
19 none of the funds made available in this paragraph may
20 be used for any audit, investigation, or review of the Medi-
21 care program.

22 UNITED STATES INSTITUTE OF PEACE

23 OPERATING EXPENSES

24 For necessary expenses of the United States Institute
25 of Peace as authorized in the United States Institute of
26 Peace Act, \$11,160,000.

1 TITLE V—GENERAL PROVISIONS

2 SEC. 501. The Secretaries of Labor, Health and
3 Human Services, and Education are authorized to transfer
4 unexpended balances of prior appropriations to accounts
5 corresponding to current appropriations provided in this
6 Act: *Provided*, That such transferred balances are used for
7 the same purpose, and for the same periods of time, for
8 which they were originally appropriated.

9 SEC. 502. No part of any appropriation contained in
10 this Act shall remain available for obligation beyond the
11 current fiscal year unless expressly so provided herein.

12 SEC. 503. (a) No part of any appropriation contained
13 in this Act shall be used, other than for normal and recog-
14 nized executive-legislative relationships, for publicity or
15 propaganda purposes, for the preparation, distribution, or
16 use of any kit, pamphlet, booklet, publication, radio, tele-
17 vision, or video presentation designed to support or defeat
18 legislation pending before the Congress, except in presen-
19 tation to the Congress itself.

20 (b) No part of any appropriation contained in this
21 Act shall be used to pay the salary or expenses of any
22 grant or contract recipient, or agent acting for such recipi-
23 ent, related to any activity designed to influence legislation
24 or appropriations pending before the Congress.

1 SEC. 504. The Secretaries of Labor and Education
2 are each authorized to make available not to exceed
3 \$15,000 from funds available for salaries and expenses
4 under titles I and III, respectively, for official reception
5 and representation expenses; the Director of the Federal
6 Mediation and Conciliation Service is authorized to make
7 available for official reception and representation expenses
8 not to exceed \$2,500 from the funds available for “Sala-
9 ries and expenses, Federal Mediation and Conciliation
10 Service”; and the Chairman of the National Mediation
11 Board is authorized to make available for official reception
12 and representation expenses not to exceed \$2,500 from
13 funds available for “Salaries and expenses, National Medi-
14 ation Board”.

15 SEC. 505. Notwithstanding any other provision of
16 this Act, no funds appropriated under this Act shall be
17 used to carry out any program of distributing sterile nee-
18 dles for the hypodermic injection of any illegal drug unless
19 the Secretary of Health and Human Services determines
20 that such programs are effective in preventing the spread
21 of HIV and do not encourage the use of illegal drugs.

22 SEC. 506. (a) PURCHASE OF AMERICAN-MADE
23 EQUIPMENT AND PRODUCTS.—It is the sense of the Con-
24 gress that, to the greatest extent practicable, all equip-

1 ment and products purchased with funds made available
2 in this Act should be American-made.

3 (b) NOTICE REQUIREMENT.—In providing financial
4 assistance to, or entering into any contract with, any en-
5 tity using funds made available in this Act, the head of
6 each Federal agency, to the greatest extent practicable,
7 shall provide to such entity a notice describing the state-
8 ment made in subsection (a) by the Congress.

9 SEC. 507. When issuing statements, press releases,
10 requests for proposals, bid solicitations and other docu-
11 ments describing projects or programs funded in whole or
12 in part with Federal money, all grantees receiving Federal
13 funds, including but not limited to State and local govern-
14 ments and recipients of Federal research grants, shall
15 clearly state (1) the percentage of the total costs of the
16 program or project which will be financed with Federal
17 money, (2) the dollar amount of Federal funds for the
18 project or program, and (3) percentage and dollar amount
19 of the total costs of the project or program that will be
20 financed by nongovernmental sources.

21 SEC. 508. None of the funds appropriated under this
22 Act shall be expended for any abortion except when it is
23 made known to the Federal entity or official to which
24 funds are appropriated under this Act that such procedure

1 is necessary to save the life of the mother or that the preg-
2 nancy is the result of an act of rape or incest.

3 SEC. 509. Notwithstanding any other provision of
4 law—

5 (1) no amount may be transferred from an ap-
6 propriation account for the Departments of Labor,
7 Health and Human Services, and Education except
8 as authorized in this or any subsequent appropria-
9 tion act, or in the Act establishing the program or
10 activity for which funds are contained in this Act;

11 (2) no department, agency, or other entity,
12 other than the one responsible for administering the
13 program or activity for which an appropriation is
14 made in this Act, may exercise authority for the tim-
15 ing of the obligation and expenditure of such appro-
16 priation, or for the purposes for which it is obligated
17 and expended, except to the extent and in the man-
18 ner otherwise provided in sections 1512 and 1513 of
19 title 31, United States Code; and

20 (3) no funds provided under this Act shall be
21 available for the salary (or any part thereof) of an
22 employee who is reassigned on a temporary detail
23 basis to another position in the employing agency or
24 department or in any other agency or department,

1 unless the detail is independently approved by the
2 head of the employing department or agency.

3 SEC. 510. None of the funds made available in this
4 Act may be used for the expenses of an electronic benefit
5 transfer (EBT) task force.

6 SEC. 511. None of the funds made available in this
7 Act may be used to enforce the requirements of section
8 428(b)(1)(U)(iii) of the Higher Education Act of 1965
9 with respect to any lender when it is made known to the
10 Federal official having authority to obligate or expend
11 such funds that the lender has a loan portfolio under part
12 B of title IV of such Act that is equal to or less than
13 \$5,000,000.

14 SEC. 512. (a) None of the funds made available in
15 this Act may be used for—

16 (1) the creation of a human embryo or embryos
17 for research purposes; or

18 (2) research in which a human embryo or em-
19 bryos are destroyed, discarded, or knowingly sub-
20 jected to risk of injury or death greater than that
21 allowed for research on fetuses in utero under 45
22 CFR 46.208(a)(2) and section 498(b) of the Public
23 Health Service Act (42 U.S.C. 289g(b)).

24 (b) For purposes of this section, the term “human
25 embryo or embryos” include any organism, not protected

1 as a human subject under 45 CFR 46 as of the date of
2 the enactment of this Act, that is derived by fertilization,
3 parthenogenesis, cloning, or any other means from one or
4 more human gametes.

5 SEC. 513. None of the funds made available in this
6 Act may be used by the National Labor Relations Board
7 to assert jurisdiction over any labor dispute when it is
8 made known to the Federal official having authority to
9 obligate or expend such funds that—

10 (1) the labor dispute does not involve any class
11 or category of employer over which the Board would
12 assert jurisdiction under the standards prevailing on
13 August 1, 1959, with each financial threshold
14 amount adjusted for inflation by—

15 (A) using changes in the Consumer Price
16 Index for all urban consumers published by the
17 Department of Labor;

18 (B) using as the base period the later of
19 (i) the most recent calendar quarter ending be-
20 fore the financial threshold amount was estab-
21 lished; or (ii) the calendar quarter ending June
22 30, 1959; and

23 (C) rounding the adjusted financial thresh-
24 old amount to the nearest \$10,000; and

1 (2) the effect of the labor dispute on interstate
2 commerce is not otherwise sufficiently substantial to
3 warrant the exercise of the Board’s jurisdiction.

4 SEC. 514. None of the funds made available in this
5 Act may be used to provide any direct benefit or assistance
6 to any individual in the United States when it is made
7 known to the Federal official having authority to obligate
8 or expend such funds that—

9 (1) the individual is not lawfully within the
10 United States; and

11 (2) the benefit or assistance to be provided is
12 other than emergency medical assistance or a benefit
13 mandated by the federal courts to be provided by the
14 State.

15 This Act may be cited as the “Departments of Labor,
16 Health and Human Services, and Education, and Related
17 Agencies Appropriations Act, 1997”.
