REPORT

[To accompany H. Res. 446]

The Committee on Rules, having had under consideration House Resolution 446, by a record vote of 7 to 4, report the same to the House with the recommendation that the resolution be adopted.

BRIEF SUMMARY OF PROVISIONS OF RESOLUTION

The resolution waives all points of order against the conference report to accompany S. 1150 [except those arising under clause 3 of rule XXVIII (pertaining to the scope of the conference) and predicated on provisions in subtitle A of title V (relating to the Food Stamp Program)] and against its consideration [except those arising under section 425 of the Congressional Budget Act (relating to Unfunded Mandates)].

The rule provides that if a point of order against the conference report is sustained for failure to comply with clause 3 of rule XXVIII the conference report shall be considered as rejected and the pending question shall be whether the House shall recede from its amendment and agree to an amendment to the Senate bill consisting of the text of the conference report as modified.
