**A BILL**

To amend the Occupational Safety and Health Act of 1970

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Occupational Safety  
5 and Health Review Commission Efficiency Act of 2005”.

6 **SEC. 2. OCCUPATIONAL SAFETY AND HEALTH REVIEW**  
7 **COMMISSION.**

8 (a) INCREASE IN NUMBER OF MEMBERS AND RE-  
9 QUIREMENT FOR MEMBERSHIP.—Section 12 of the Occu-  
10 pational Safety and Health Act of 1970 (29 U.S.C. 661)  
11 is amended—

12 (1) in the second sentence of subsection (a)—

13 (A) by striking “three members” and in-  
14 serting “five members”; and

15 (B) by inserting “legal” before “training”;

16 (2) in the first sentence of subsection (b), by  
17 striking “except that” and all that follows through  
18 the period and inserting the following: “except that  
19 the President may extend the term of a member for  
20 no more than 365 consecutive days to allow a con-  
21 tinuation in service at the pleasure of the President  
22 after the expiration of the term of that member until  
23 a successor nominated by the President has been  
24 confirmed to serve. Any vacancy caused by the  
25 death, resignation, or removal of a member before

1 the expiration of a term for which a member was ap-  
2 pointed shall be filled only for the remainder of such  
3 term.”; and

4 (3) in subsection (f), by striking “two mem-  
5 bers” each place it appears and inserting “three  
6 members”.

7 (b) NEW POSITIONS.—Of the two vacancies for mem-  
8 bership on the Occupational Safety and Health Review  
9 Commission created by subsection (a)(1)(A), one shall be  
10 appointed by the President for a term expiring on April  
11 27, 2008, and the other shall be appointed by the Presi-  
12 dent for a term expiring on April 27, 2010.

13 (c) EFFECTIVE DATE FOR LEGAL TRAINING RE-  
14 QUIREMENT.—The amendment made by subsection  
15 (a)(1)(B), requiring a member of the Commission to pos-  
16 sess a background in legal training, shall apply beginning  
17 with the two vacancies referred to in subsection (b) and  
18 all subsequent appointments to the Commission.

19 **SECTION 1. SHORT TITLE.**

20 *This Act may be cited as the “Occupational Safety and*  
21 *Health Review Commission Efficiency Act of 2005”.*

22 **SEC. 2. OCCUPATIONAL SAFETY AND HEALTH REVIEW COM-**  
23 **MISSION.**

24 (a) INCREASE IN NUMBER OF MEMBERS AND CRI-  
25 TERIA FOR MEMBERSHIP.—Section 12 of the Occupational

1 *Safety and Health Act of 1970 (29 U.S.C. 661) is amend-*  
2 *ed—*

3 (1) *in the second sentence of subsection (a)—*

4 (A) *by striking “three members” and insert-*  
5 *ing “five members”; and*

6 (B) *by inserting “legal” before “training”;*

7 (2) *in the first sentence of subsection (b), by*  
8 *striking “except that” and all that follows through the*  
9 *period and inserting the following: “except that the*  
10 *President may extend the term of a member for no*  
11 *more than 365 consecutive days to allow a continu-*  
12 *ation in service at the pleasure of the President after*  
13 *the expiration of the term of that member until a suc-*  
14 *cessor nominated by the President has been confirmed*  
15 *to serve. Any vacancy caused by the death, resigna-*  
16 *tion, or removal of a member before the expiration of*  
17 *a term for which a member was appointed shall be*  
18 *filled only for the remainder of such term.”; and*

19 (3) *in subsection (f), by striking “two members”*  
20 *the first place it appears and inserting “three mem-*  
21 *bers”.*

22 (b) *NEW POSITIONS.—Of the two vacancies for mem-*  
23 *bership on the Occupational Safety and Health Review*  
24 *Commission created by subsection (a)(1)(A), one shall be*  
25 *appointed by the President for a term expiring on April*

1 27, 2008, and the other shall be appointed by the President  
2 for a term expiring on April 27, 2010.

3 (c) *EFFECTIVE DATE.*—The amendment made by sub-  
4 section (a)(1)(B) shall apply beginning with the 2 vacancies  
5 referred to in subsection (b) and all subsequent appoint-  
6 ments to the Commission.
