# A BILL

Making appropriations for the Legislative Branch for the fiscal year ending September 30, 2012, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,

- 1 That the following sums are appropriated, out of any
- 2 money in the Treasury not otherwise appropriated, for the
- 3 Legislative Branch for the fiscal year ending September
- 4 30, 2012, and for other purposes, namely:
- 5 TITLE I—LEGISLATIVE BRANCH
- 6 HOUSE OF REPRESENTATIVES
- 7 Salaries and Expenses
- 8 For salaries and expenses of the House of Represent-
- 9 atives, \$1,226,680,000, as follows:
- 10 HOUSE LEADERSHIP OFFICES
- 11 For salaries and expenses, as authorized by law,
- 12 \$23,275,773, including: Office of the Speaker,
- 13 \$6,942,770, including \$25,000 for official expenses of the
- 14 Speaker; Office of the Majority Floor Leader, \$2,277,595,
- 15 including \$10,000 for official expenses of the Majority
- 16 Leader; Office of the Minority Floor Leader, \$7,432,812,
- 17 including \$10,000 for official expenses of the Minority

- 23 STANDING COMMITTEES, SPECIAL AND SELECT
- 24 For salaries and expenses of standing committees,
- 25 special and select, authorized by House resolutions,

- 1 \$125,964,870: Provided, That such amount shall remain
- 2 available for such salaries and expenses until December
- 3 31, 2012.
- 4 Committee on Appropriations

- 21 available until expended; for salaries and expenses of the
- 22 Office of the Sergeant at Arms, including the position of

- 11 tarian, \$2,000 for preparing the Digest of Rules, and not
- 12 more than \$1,000 for official representation and reception
- 13 expenses, \$2,060,000; for salaries and expenses of the Of-
- 14 fice of the Law Revision Counsel of the House,
- 15 \$3,258,000; for salaries and expenses of the Office of the
- 16 Legislative Counsel of the House, \$8,814,000; for salaries
- 17 and expenses of the Office of Interparliamentary Affairs,
- 18 \$859,000; for other authorized employees, \$347,000; and
- 19 for salaries and expenses of the Historian, \$170,000.
- 20 Allowances and Expenses
- 21 For allowances and expenses as authorized by House
- 22 resolution or law, \$293,386,942, including: supplies, mate-
- 23 rials, administrative costs and Federal tort claims,
- 24 \$3,696,118; official mail for committees, leadership of-
- 25 fices, and administrative offices of the House, \$201,000;

- 1 Government contributions for health, retirement, Social
- 2 Security, and other applicable employee benefits,
- 3 \$264,848,219; Business Continuity and Disaster Recov-
- 4 ery, \$17,112,072, of which \$5,000,000 shall remain avail-
- 5 able until expended; transition activities for new members
- 6 and staff, \$2,721,533; Wounded Warrior Program
- 7 \$2,500,000, to remain available until expended; Office of
- 8 Congressional Ethics, \$1,548,000; and miscellaneous
- 9 items including purchase, exchange, maintenance, repair
- 10 and operation of House motor vehicles, interparliamentary
- 11 receptions, and gratuities to heirs of deceased employees
- 12 of the House, \$760,000.
- 13 Administrative Provisions
- 14 Sec. 101. (a) Requiring Amounts Remaining in
- 15 Members' Representational Allowances To Be
- 16 Used for Deficit Reduction or To Reduce the
- 17 Federal Debt.—Notwithstanding any other provision of
- 18 law, any amounts appropriated under this Act for
- 19 "HOUSE OF REPRESENTATIVES—SALARIES AND
- 20 Expenses—Members' Representational Allow-
- 21 ANCES" shall be available only for fiscal year 2012. Any
- 22 amount remaining after all payments are made under such
- 23 allowances for fiscal year 2012 shall be deposited in the

### (b) AUTHORITY OF MINORITY LEADER.—

(1) AUTHORITY DESCRIBED.—Notwithstanding any other provision of law (including any provision of law that sets forth an allowance for official expenses), the amount appropriated or otherwise made available during a Congress for the salaries and expenses of any office or authority described in paragraph (2) shall be the amount allocated for such office or authority by the Minority Leader of the

(c) Effective Date.—This section shall apply with 1 2 respect to any months occurring during the One Hundred 3 Twelfth Congress that begin after the date of the enactment of this Act, and to any succeeding Congress. 5 Republican Conference and the Democratic 6 STEERING AND POLICY COMMITTEE 7 SEC. 104. 8	For salaries of employees of the Capitol Police, in-
9	cluding overtime, hazardous duty pay, and Government
10	contributions for health, retirement, social security, pro-
11	fessional liability insurance, and other applicable employee
12	benefits, \$277,132,624, to be disbursed by the Chief of
13	the Capitol Police or his designee.
14	General Expenses
15	For necessary expenses of the Capitol Police, includ-
16	ing motor vehicles, communications and other equipment,

20	services, the employee assistance program, the awards pro-

- Sec. 1002. (a) Waiver of Claim.—Subject to the
- 21 approval of the Capitol Police Board, the Chief of the
- 22 United States Capitol Police may waive in whole or in part
- 23 a claim of the United States against a person arising out
- 24 of an erroneous payment of any pay or allowances, other
- 25 than travel and transportation expenses and allowances,

- 1 to an officer, member, or employee of the United States
- 2 Capitol Police, if the collection of the claim would be
- 3 against equity and good conscience and not in the best
- 4 interests of the United States.
- 5 (b) Investigation of Application; Report.—The
- 6 Chief shall investigate each application for the waiver of
- 7 a claim under subsection (a) and shall submit a written
- 8 report of the investigation to the Capitol Police Board, ex-
- 9 cept that if the aggregate amount of the claim involved
- 10 exceeds \$1,500, the Comptroller General may also inves-
- 11 tigate the application and submit a written report of the
- 12 investigation to the Capitol Police Board.
- 13 (c) Prohibition of Waiver Under Certain Cir-
- 14 CUMSTANCES.—The Chief may not exercise the authority
- 15 to waive a claim under subsection (a) if—
- 16 (1) in the Chief's opinion, there exists in con-
- 17 nection with the claim an indication of fraud, mis-
- representation, fault, or lack of good faith on the
- part of the officer, member, or employee involved or
- of any other person having an interest in obtaining
- a waiver of the claim; or
- 22 (2) the Chief receives the application for the
- waiver after the expiration of the 3-year period that
- begins on the date on which the erroneous payment
- of pay or allowances was discovered.

- 1 (d) Credit for Waiver.—In the audit and settle-
- 2 ment of accounts of any accountable officer or official, full
- 3 credit shall be given for any amounts with respect to which
- 4 collection by the United States is waived under subsection
- 5 (a).
- 6 (e) Effect of Waiver.—An erroneous payment,
- 7 the collection of which is waived under subsection (a), is
- 8 deemed a valid payment for all purposes.
- 9 (f) Construction With Other Laws.—This sec-
- 10 tion does not affect any authority under any other law
- 11 to litigate, settle, compromise, or waive any claim of the
- 12 United States.
- 13 (g) RULES AND REGULATIONS.—The Chief shall pro-
- 14 mulgate rules and regulations to carry out this section.
- 15 (h) Effective Date.—This section shall apply with
- 16 respect to payments of pay and allowances made at any
- 17 time after the Chief became the disbursing officer for the
- 18 United States Capitol Police pursuant to section 1018(a)
- 19 of the Legislative Branch Appropriations Act, 2003 (2
- 20 U.S.C. 1907(a)).

13	ARCHITECT OF THE CAPITOL
14	GENERAL ADMINISTRATION
15	For salaries for the Architect of the Capitol, and
16	other personal services, at rates of pay provided by law;
17	for surveys and studies in connection with activities under
18	the care of the Architect of the Capitol; for all necessary
19	expenses for the general and administrative support of the
20	operations under the Architect of the Capitol including the
21	Botanic Garden; electrical substations of the Capitol, Sen-
22	ate and House office buildings, and other facilities under
23	the jurisdiction of the Architect of the Capitol; including
23 24	the jurisdiction of the Architect of the Capitol; including furnishings and office equipment; including not more than

- 1 to be expended as the Architect of the Capitol may ap-
- 2 prove; for purchase or exchange, maintenance, and oper-
- 3 ation of a passenger motor vehicle, \$104,790,000, of
- 4 which \$3,199,000 shall remain available until September
- 5 30, 2016.
- 6 CAPITOL BUILDING
- 7 For all necessary expenses for the maintenance, care
- 8 and operation of the Capitol, \$35,354,000, of which
- 9 \$10,263,000 shall remain available until September 30,
- 10 2016.
- 11 CAPITOL GROUNDS
- For all necessary expenses for care and improvement
- 13 of grounds surrounding the Capitol, the Senate and House
- 14 office buildings, and the Capitol Power Plant, \$9,852,000.
- House Office Buildings
- 16 For all necessary expenses for the maintenance, care
- 17 and operation of the House office buildings, \$89,154,000,
- 18 of which \$40,631,000 shall remain available until Sep-
- 19 tember 30, 2016.
- In addition, for a payment to the House Historic
- 21 Buildings Revitalization Trust Fund, \$30,000,000, shall
- 22 remain available until expended.
- 23 CAPITOL POWER PLANT
- 24 For all necessary expenses for the maintenance, care
- 25 and operation of the Capitol Power Plant; lighting, heat-

- 1 ing, power (including the purchase of electrical energy)
- 2 and water and sewer services for the Capitol, Senate and
- 3 House office buildings, Library of Congress buildings, and
- 4 the grounds about the same, Botanic Garden, Senate ga-
