SECTION 1. EXPANSION OF ELIGIBILITY FOR HEADSTONES, MARKERS, AND MEDALLIONS FOR MEDAL OF HONOR RECIPIENTS.

4 Section 2306(d) of title 38, United States Code, is
5 amended by adding at the end the following new para6 graph:

7 "(5)(A) In carrying out this subsection with respect
8 to a deceased individual described in subparagraph (C),
9 the Secretary shall furnish, upon request, a headstone or
10 marker under paragraph (1) or a medallion under para11 graph (4) that signifies the deceased's status as a Medal
12 of Honor recipient.

13 "(B) If the Secretary furnished a headstone, marker, or medallion under paragraph (1) or (4) for a deceased 14 individual described in subparagraph (C) that does not 15 16 signify the deceased's status as a Medal of Honor recipient, the Secretary shall, upon request, replace such head-17 18 stone, marker, or medallion with a headstone, marker, or 19 medallion, as the case may be, that so signifies the 20deceased's status as a Medal of Honor recipient.

21 "(C) A deceased individual described in this subpara-22 graph is a deceased individual who—

23 "(i) served in the Armed Forces on or after
24 April 6, 1917;

4 "(iii) was awarded the Medal of Honor (includ-5 ing posthumously).".

6 SEC. 2. EXPANSION OF PRESIDENTIAL MEMORIAL CERTIFI7 CATE PROGRAM.

8 (a) IN GENERAL.—Section 112(a) of title 38, United 9 States Code, is amended by striking "veterans," and all 10 that follows through "service," and inserting the following: 11 "persons eligible for burial in a national cemetery by rea-12 son of any of paragraphs (1), (2), (3), or (7) of section 13 2402(a) of this title,".

(b) APPLICATION.—The amendment made by subsection (a) shall apply with respect to the death of a person eligible for burial in a national cemetery by reason
of paragraph (1), (2), (3), or (7) of section 2402(a) of
title 38, United States Code, occurring before, on, or after
the date of the enactment of this Act.
