## RESOLUTION

Providing for consideration of the bill (H.R. 3134) to provide for a moratorium on Federal funding to Planned Parenthood Federation of America, Inc.; providing for consideration of the bill (H.R. 3504) to amend title 18, United States Code, to prohibit a health care practitioner from failing to exercise the proper degree of care in the case of a child who survives an abortion or attempted abortion; and for other purposes.

1       *Resolved*, That upon adoption of this resolution it  
2 shall be in order to consider in the House the bill (H.R.  
3 3134) to provide for a moratorium on Federal funding to  
4 Planned Parenthood Federation of America, Inc. All  
5 points of order against consideration of the bill are waived.  
6 The amendment printed in the report of the Committee  
7 on Rules accompanying this resolution shall be considered  
8 as adopted. The bill, as amended, shall be considered as  
9 read. All points of order against provisions in the bill, as  
10 amended, are waived. The previous question shall be con-  
11 sidered as ordered on the bill, as amended, and on any  
12 further amendment thereto, to final passage without inter-  
13 vening motion except: (1) one hour of debate equally di-  
14 vided and controlled by the chair and ranking minority  
15 member of the Committee on Energy and Commerce or  
16 their respective designees; and (2) one motion to recommit  
17 with or without instructions.

18       SEC. 2. Upon adoption of this resolution it shall be  
19 in order to consider in the House the bill (H.R. 3504)  
20 to amend title 18, United States Code, to prohibit a health  
21 care practitioner from failing to exercise the proper degree  
22 of care in the case of a child who survives an abortion  
23 or attempted abortion. All points of order against consid-  
24 eration of the bill are waived. The bill shall be considered  
25 as read. All points of order against provisions in the bill

1 are waived. The previous question shall be considered as  
2 ordered on the bill and on any amendment thereto to final  
3 passage without intervening motion except: (1) one hour  
4 of debate equally divided and controlled by the chair and  
5 ranking minority member of the Committee on the Judici-  
6 ary or their respective designees; and (2) one motion to  
7 recommit.

8       SEC. 3. Upon passage of H.R. 3134 the House shall  
9 be considered to have: (1) stricken all after the enacting  
10 clause of S. 764 and inserted in lieu thereof the provisions  
11 of H.R. 3134, as passed by the House; and (2) passed  
12 the Senate bill as so amended.

13       SEC. 4. Upon passage of H.R. 3504 the House shall  
14 be considered to have: (1) stricken all after the enacting  
15 clause of S. 1603 and inserted in lieu thereof the provi-  
16 sions of H.R. 3504, as passed by the House; and (2)  
17 passed the Senate bill as so amended.

18       SEC. 5. House Resolution 408 is laid on the table.
