A BILL

To provide for joint reports by relevant Federal agencies to Congress regarding incidents of terrorism, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Reporting Efficiently*
5 *to Proper Officials in Response to Terrorism Act of 2017”*
6 *or the “REPORT Act”.*

7 **SEC. 2. DUTY TO REPORT.**

8 (a) *DUTY IMPOSED.*—*Whenever an act of terrorism oc-*
9 *curs in the United States, it shall be the duty of the Sec-*
10 *retary of Homeland Security, in coordination with the At-*
11 *torney General, the Director of the Federal Bureau of Inves-*
12 *tigation, and, as appropriate, the head of the National*
13 *Counterterrorism Center, to submit, within one year of the*
14 *completion of the investigation concerning such act by the*
15 *primary Government agency conducting such investigation,*
16 *an unclassified report (which may be accompanied by a*
17 *classified annex) to Congress concerning such act.*

18 (b) *CONTENT OF REPORTS.*—*A report under this sec-*
19 *tion shall—*

20 (1) *include a statement of the facts of the act of*
21 *terrorism referred to in subsection (a), as known at*
22 *the time of the report;*

23 (2) *identity any gaps in national security that*
24 *could be addressed to prevent future acts of terrorism;*
25 *and*

1 (3) *any recommendations for additional meas-*
2 *ures that could be taken to improve homeland secu-*
3 *rity, including potential changes in law enforcement*
4 *practices or changes in law, consistent with the Con-*
5 *stitution, with particular attention to changes that*
6 *could help prevent future acts of terrorism.*

7 (c) *EXCEPTION.—The duty established under sub-*
8 *section (a) shall not apply in instances in which the Sec-*
9 *retary of Homeland Security, the Attorney General, the Di-*
10 *rector of the Federal Bureau of Investigation, or the head*
11 *of the National Counterterrorism Center determines that the*
12 *information required to be reported could jeopardize an on-*
13 *going investigation or prosecution. In such instances, the*
14 *Secretary shall notify Congress of such prior to the first*
15 *anniversary of the completion of the investigation described*
16 *in such subsection.*

17 (d) *DEFINITION.—In this section, the term “act of ter-*
18 *rorism” has the meaning given such term in section 3077*
19 *of title 18, United States Code.*
