#### 3 SEC. 3. PROPOSAL RELATED TO SHARED SERVICES.

4 Not later than 180 days after the date of the enact-5 ment of this Act, the Federal Chief Information Officer shall submit to Congress a proposal for consolidating in-6 7 formation technology across the Federal Government, es-8 pecially among Federal agencies not referred to under sec-9 tion 901(b) of title 31, United States Code, and increasing 10 the use of shared services, including any recommendations for legislative changes that may be necessary to effect the 11 12 proposal.

#### 13 SEC. 4. NO ADDITIONAL FUNDS AUTHORIZED.

14 No additional funds are authorized to be appro-15 priated to carry out this Act and the amendments made 16 by this Act. This Act and the amendments made by this 17 Act shall be carried out using amounts otherwise author-18 ized.
