RESOLUTION

Providing for consideration of the bill (H.R. 1219) to amend the Investment Company Act of 1940 to expand the investor limitation for qualifying venture capital funds under an exemption from the definition of an investment company, and providing for proceedings during the period from April 7, 2017, through April 24, 2017.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the bill (H.R.
3 1219) to amend the Investment Company Act of 1940 to

1 expand the investor limitation for qualifying venture cap-
2 ital funds under an exemption from the definition of an
3 investment company. All points of order against consider-
4 ation of the bill are waived. The bill shall be considered
5 as read. All points of order against provisions in the bill
6 are waived. The previous question shall be considered as
7 ordered on the bill and on any amendment thereto to final
8 passage without intervening motion except: (1) one hour
9 of debate equally divided and controlled by the chair and
10 ranking minority member of the Committee on Financial
11 Services; and (2) one motion to recommit.

12 SEC. 2. . On any legislative day during the period
13 from April 7, 2017, through April 24, 2017—

14 (a) the Journal of the proceedings of the previous day
15 shall be considered as approved; and

16 (b) the Chair may at any time declare the House ad-
17 journed to meet at a date and time, within the limits of
18 clause 4, section 5, article I of the Constitution, to be an-
19 nounced by the Chair in declaring the adjournment.

20 SEC. 3. The Speaker may appoint Members to per-
21 form the duties of the Chair for the duration of the period
22 addressed by section 2 of this resolution as though under
23 clause 8(a) of rule I.

24 SEC. 4. Each day during the period addressed by sec-
25 tion 2 of this resolution shall not constitute a calendar

1 day for purposes of section 7 of the War Powers Resolu-
2 tion (50 U.S.C. 1546).

3 SEC. 5. Each day during the period addressed by sec-
4 tion 2 of this resolution shall not constitute a legislative
5 day for purposes of clause 7 of rule XIII.
