## RESOLUTION

Providing for consideration of the bill (H.R. 3823) to amend title 49, United States Code, to extend authorizations for the airport improvement program, to amend the Internal Revenue Code of 1986 to extend the funding and expenditure authority of the Airport and Airway Trust Fund, to provide disaster tax relief, and for other purposes, and providing for consideration of motions to suspend the rules.

1       *Resolved*, That upon adoption of this resolution it  
2 shall be in order to consider in the House, without inter-  
3 vention of any question of consideration, the bill (H.R.  
4 3823) to amend title 49, United States Code, to extend  
5 authorizations for the airport improvement program, to  
6 amend the Internal Revenue Code of 1986 to extend the  
7 funding and expenditure authority of the Airport and Air-  
8 way Trust Fund, to provide disaster tax relief, and for  
9 other purposes. All points of order against consideration  
10 of the bill are waived. The amendment printed in the re-  
11 port of the Committee on Rules accompanying this resolu-  
12 tion shall be considered as adopted. The bill, as amended,  
13 shall be considered as read. All points of order against  
14 provisions in the bill, as amended, are waived. The pre-  
15 vious question shall be considered as ordered on the bill,  
16 as amended, and on any further amendment thereto, to  
17 final passage without intervening motion except: (1) one  
18 hour of debate, with 40 minutes equally divided and con-  
19 trolled by the chair and ranking minority member of the  
20 Committee on Ways and Means and 20 minutes equally  
21 divided and controlled by the chair and ranking minority  
22 member of the Committee on Financial Services; and (2)  
23 one motion to recommit with or without instructions.

24       SEC. 2. It shall be in order at any time on the legisla-  
25 tive day of September 28, 2017, for the Speaker to enter-

1 tain motions that the House suspend the rules as though  
2 under clause 1 of rule XV. The Speaker or his designee  
3 shall consult with the Minority Leader or her designee on  
4 the designation of any matter for consideration pursuant  
5 to this section.
