House Armed Services Committee, my mentor, my former boss, the late Congressman Ron Dellums. Congressman Dellums broke barriers as the first Black chairman of the House Armed Services Committee. He was also an avid champion of diversity at all levels.

In the 1970s, he hired me to work on his staff as one of the only women of color in a senior role on Capitol Hill. He was a pioneer and a visionary who understood the need for elevating women of color in every field.

That is why my bill, which has the support of organizations like the Civic Engagement and Leadership Institute for Everyone is so important. It will help honor Ron's legacy, build greater diversity in national security, and create much more STEAM opportunities for women of color.

Mr. Speaker, I urge my colleagues to join me by cosponsoring my bill, the Ronald Dellums Memorial Fellowship for Women of Color in STEAM and National Security Act.

HONORING THE LIFE OF SERGEANT BENTON BERTRAM

Mr. HOLLINGSWORTH. Mr. Speaker, every morning our heroes in law enforcement wake up and they kiss their loved ones good-bye, knowing that there is always a chance they may not return that night.

Last night, in Charlestown, in Clark County, in the Hoosier State, one of those heroes, Sergeant Ben Bertram of the Charlestown Police Department did not return home. COMMENDING SONNY PERDUE

(Mr. LAMALFA asked and was given permission to address the House for 1 minute and to revise and extend his remarks.)

Mr. LAMALFA. Mr. Speaker, I want to thank and commend Secretary Sonny Perdue of the USDA for a recent decision to help northern California with its water situation. They are offering a \$449 million loan to help the Sites area project, an intertie that will help the Tehama-Colusa Canal and the Glenn-Colusa Canal intertie to each other, and, therefore, be part of the infrastructure that will help the Sites Reservoir be successful when it is finally built.

It is much needed for northern California's water interconnectivity, flexibility, and overall goals of more water storage in our State, especially upon the heels of the California State Water Resources Control Board's shift of what could be up to 700,000 more acre feet away from human use towards dubious environmental use.

Mr. Speaker, we need help with water storage, water capacity. I thank Secretary Perdue and Secretary Zinke for their attention to northern California for these water needs, and thank the Trump administration for it as well.

CONGRESSIONAL ACCOUNTABILITY ACT OF 1995 REFORM ACT

Mr. HARPER. Mr. Speaker, I ask unanimous consent to take from the Speaker's table the bill (S. 3749) to amend the Congressional Accountability Act of 1995 to reform the procedures provided under such Act for the initiation, review, and resolution of claims alleging that employing offices of the legislative branch have violated the rights and protections provided to their employees under such Act, including protections against sexual harassment, and for other purposes, and ask for its immediate consideration in the House.

The Clerk read the title of the bill.

The SPEAKER pro tempore (Mr. BYRNE). Is there objection to the request of the gentleman from Mississippi?

There was no objection.

The text of the bill is as follows:

S. 3749

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled.

SECTION 1. SHORT TITLE; REFERENCES IN ACT; TABLE OF CONTENTS.

(a) SHORT TITLE.—This Act may be cited as the "Congressional Accountability Act of 1995 Reform Act"

(b) REFERENCES IN ACT.-Except as otherwise expressly provided, whenever in this Act an amendment or repeal is expressed in terms of an amendment to or repeal of a section or other provision, the reference shall be considered to be made to that section or other provision of the Congressional Accountability Act of 1995 (2 U.S.C. 1301 et seq.).

(a) PROCEDURES DESCRIBED.—Section 401 (2 U.S.C. 1401) is amended to read as follows:

"SEC. 401. PROCEDURE FOR CONSIDERATION OF ALLEGED VIOLATIONS.

"(a) FILING AND REVIEW OF CLAIMS .- Except as otherwise provided, the procedure for consideration of an alleged violation of part A of title II consists of-

``(1) the filing of a claim by the covered employee alleging the violation, as provided in section 402:

"(2) the preliminary review of the claim, to be conducted by a hearing officer as provided in section 403;

"(3) mediation as provided in section 404, if requested and agreed to by the parties under that section; and

"(4) a formal hearing as provided in section 405, subject to Board review as provided in section 406 and judicial review in the United States Court of Appeals for the Federal Circuit as provided in section 407.

"(b) RIGHT OF EMPLOYEE TO FILE CIVIL AC-TION.

"(1) CIVIL ACTION .- Only a covered employee who has filed a claim timely as provided in section 402 and who has not submitted a request for a hearing on the claim pursuant to section 405(a) may, during the
