- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Long-Term Care Vet-
- 5 erans Choice Act".

- 4 (a) AUTHORITY.—Section 1720 of title 38, United
- 5 States Code, is amended by adding at the end the fol-
- 6 lowing new subsection:
- 7 "(h)(1) During the three-year period beginning on
- 8 October 1, 2020, and subject to paragraph (2), at the re-
- 9 quest of a veteran for whom the Secretary is required to
- 10 provide nursing home care under section 1710A of this
- 11 title, the Secretary may place the veteran in a medical fos-
- 12 ter home that meets Department standards, at the ex-
- 13 pense of the United States, pursuant to a contract, agree-
- 14 ment, or other arrangement entered into between the Sec-
- 15 retary and the medical foster home for such purpose. A
- 16 veteran who is placed in a medical foster home under this
- 17 subsection shall agree, as a condition of such placement,
- 18 to accept home health services furnished by the Secretary
- 19 under section 1717 of this title.
- 20 "(2) In any year, not more than a daily average of
- 21 900 veterans placed in a medical foster home, whether
- 22 placed before or after the date of the enactment of this
- 23 subsection, may have their care covered at the expense of
- 24 the United States under subsection (a).
- 25 "(3) In this subsection, the term 'medical foster
- 26 home' means a home designed to provide non-institutional,

- 1 long-term, supportive care for veterans who are unable to
- 2 live independently and prefer a family setting.".

5 section (a), shall take effect on October 1, 2020.
