Mr. PERLMUTTER, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

---

## RESOLUTION

Providing for consideration of the bill (H.R. 1500) to require the Consumer Financial Protection Bureau to meet its statutory purpose, and for other purposes; providing for consideration of the bill (H.R. 1994) to amend the Internal Revenue Code of 1986 to encourage retirement savings, and for other purposes; providing for proceedings during the period from May 24, 2019, through May 31, 2019; and for other purposes.

1       *Resolved*, That at any time after adoption of this reso-  
2 lution the Speaker may, pursuant to clause 2(b) of rule  
3 XVIII, declare the House resolved into the Committee of  
4 the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 1500) to require the Consumer Fi-  
6 nancial Protection Bureau to meet its statutory purpose,  
7 and for other purposes. The first reading of the bill shall  
8 be dispensed with. All points of order against consider-  
9 ation of the bill are waived. General debate shall be con-  
10 fined to the bill and amendments specified in this section  
11 and shall not exceed one hour equally divided and con-  
12 trolled by the chair and ranking minority member of the  
13 Committee on Financial Services. After general debate the  
14 bill shall be considered for amendment under the five-  
15 minute rule. In lieu of the amendment in the nature of  
16 a substitute recommended by the Committee on Financial  
17 Services now printed in the bill, an amendment in the na-  
18 ture of a substitute consisting of the text of Rules Com-  
19 mittee Print 116-15 shall be considered as adopted in the  
20 House and in the Committee of the Whole. The bill, as  
21 amended, shall be considered as the original bill for the  
22 purpose of further amendment under the five-minute rule  
23 and shall be considered as read. All points of order against  
24 provisions in the bill, as amended, are waived. No further  
25 amendment to the bill, as amended, shall be in order ex-

1 cept those printed in part A of the report of the Com-  
2 mittee on Rules accompanying this resolution. Each such  
3 further amendment may be offered only in the order print-  
4 ed in the report, may be offered only by a Member des-  
5 igned in the report, shall be considered as read, shall  
6 be debatable for the time specified in the report equally  
7 divided and controlled by the proponent and an opponent,  
8 shall not be subject to amendment, and shall not be sub-  
9 ject to a demand for division of the question in the House  
10 or in the Committee of the Whole. All points of order  
11 against such further amendments are waived. At the con-  
12 clusion of consideration of the bill for amendment the  
13 Committee shall rise and report the bill, as amended, to  
14 the House with such further amendments as may have  
15 been adopted. The previous question shall be considered  
16 as ordered on the bill, as amended, and on any further  
17 amendment thereto to final passage without intervening  
18 motion except one motion to recommit with or without in-  
19 structions.

20       SEC. 2. Upon adoption of this resolution it shall be  
21 in order to consider in the House the bill (H.R. 1994)  
22 to amend the Internal Revenue Code of 1986 to encourage  
23 retirement savings, and for other purposes. All points of  
24 order against consideration of the bill are waived. The  
25 amendment in the nature of a substitute recommended by

1 the Committee on Ways and Means now printed in the  
2 bill, modified by the amendment printed in part B of the  
3 report of the Committee on Rules accompanying this reso-  
4 lution, shall be considered as adopted. The bill, as amend-  
5 ed, shall be considered as read. All points of order against  
6 provisions in the bill, as amended, are waived. The pre-  
7 vious question shall be considered as ordered on the bill,  
8 as amended, and on any further amendment thereto, to  
9 final passage without intervening motion except: (1) one  
10 hour of debate equally divided and controlled by the chair  
11 and ranking minority member of the Committee on Ways  
12 and Means; and (2) one motion to recommit with or with-  
13 out instructions.

14       SEC. 3. On any legislative day during the period from  
15 May 24, 2019, through May 31, 2019—

16       (a) the Journal of the proceedings of the previous day  
17 shall be considered as approved; and

18       (b) the Chair may at any time declare the House ad-  
19 journed to meet at a date and time, within the limits of  
20 clause 4, section 5, article I of the Constitution, to be an-  
21 nounced by the Chair in declaring the adjournment.

22       SEC. 4. The Speaker may appoint Members to per-  
23 form the duties of the Chair for the duration of the period  
24 addressed by section 3 of this resolution as though under  
25 clause 8(a) of rule I.

1        SEC. 5. Each day during the period addressed by sec-  
2 tion 3 of this resolution shall not constitute a legislative  
3 day for purposes of clause 7 of rule XV.

4        SEC. 6. It shall be in order at any time on the legisla-  
5 tive day of May 23, 2019, for the Speaker to entertain  
6 motions that the House suspend the rules as though under  
7 clause 1 of rule XV, relating to a measure making supple-  
8 mental appropriations for the fiscal year ending Sep-  
9 tember 30, 2019.

10       SEC. 7. The requirement of clause 6(a) of rule XIII  
11 for a two-thirds vote to consider a report from the Com-  
12 mittee on Rules on the same day it is presented to the  
13 House is waived with respect to any resolution reported  
14 through the legislative day of May 23, 2019, relating to  
15 a measure making supplemental appropriations for the fis-  
16 cal year ending September 30, 2019.

17       SEC. 8. The Committee on Appropriations may, at  
18 any time before 5:00 p.m. on Sunday, June 2, 2019, file  
19 privileged reports to accompany measures making appro-  
20 priations for the fiscal year ending September 30, 2020.
