2022 FIFA World Cup Competition: Senate agreed to H. Con. Res. 327, recognizing and supporting the efforts of the USA Bid Committee to bring the 2022 Federation Internationale de Football

Cumberland Valley Athletic Club: Committee on the Judiciary was discharged from further consideration of S. Res. 611, congratulating the Cumberland Valley Athletic Club on the 48th anniversary of the running of the JFK 50-Mile Ultra-Marathon, and the resolution was then agreed to. **Page S8205**
