Measures Introduced: Sixteen bills and one resolution were introduced, as follows: S. 1661–1676, and S. Res. 289. **Page S7927**

S. 822, to protect crime victims' rights, to eliminate the substantial backlog of DNA samples collected from crime scenes and convicted offenders, to improve and expand the DNA testing capacity of Federal, State, and local crime laboratories, to increase research and development of new DNA testing technologies, to develop new training programs regarding the collection and use of DNA evidence, to provide post conviction testing of DNA evidence to exonerate the innocent, to improve the performance of counsel in State capital cases, with amendments. **Page S7927**

Measures Passed:

Employment Non-Discrimination Act: By 64 yeas to 32 nays (Vote No. 232), Senate passed S. 815, to prohibit employment discrimination on the basis of sexual orientation or gender identity, after agreeing to the committee amendment in the nature of a substitute, and after taking action on the following amendments and motions proposed thereto:

Rejected:

By 43 yeas to 55 nays (Vote No. 230), Reid (for Toomey/Flake) Amendment No. 2013, to strike the appropriate balance between protecting workers and protecting religious freedom. (A unanimous-consent agreement was reached providing that the amendment, having failed to achieve 60 affirmative votes, the amendment was not agreed to.) **Page S7902**

Reid Amendment No. 2017 (to (the instructions of the motion to recommit) Amendment No. 2016), of a perfecting nature, fell when Reid Amendment No. 2016 was withdrawn. **Page S7894**

Reid Amendment No. 2018 (to Amendment No. 2017), of a perfecting nature, fell when Reid Amendment No. 2017 fell. **Page S7894**

By 64 yeas to 34 nays (Vote No. 231), three-fifths of those Senators duly chosen and sworn, having voted in the affirmative, Senate agreed to the motion to close further debate on the bill. **Page S7902**

40th Anniversary of Withdrawal of U.S. Combat Troops from Vietnam War: Committee on Foreign Relations was discharged from further consideration of S. Res. 280, recognizing the 40th anniversary of the withdrawal of United States combat troops from the Vietnam War and expressing renewed support for United States veterans of that conflict, and the resolution was then agreed to.

Drug Quality and Security Act—Agreement: Senate began consideration of the motion to proceed to consideration of H.R. 3204, to amend the Federal Food, Drug, and Cosmetic Act with respect to human drug compounding and drug supply chain security. **Pages S7891–94, S7909–24**

A motion was entered to close further debate on the motion to proceed to consideration of the bill, and, in accordance with the provisions of Rule XXII of the Standing Rules of the Senate, and pursuant to the unanimous-consent agreement of Thursday, November 7, 2013, a vote on cloture will occur upon disposition of the nomination of Cornelia T. L. Pillard, of the District of Columbia, to be United States Circuit Judge for the District of Columbia Circuit, on Tuesday, November 12, 2013. **Page S7932**

A unanimous-consent agreement was reached providing that if cloture is invoked on the nomination of Cornelia T. L. Pillard, upon disposition of the nomination, Senate resume consideration of the motion to proceed to consideration of the bill, and vote on the motion to invoke cloture on the motion to proceed to consideration of the bill; and that if cloture is not invoked on the nomination, Senate immediately resume the motion to proceed to consideration of the bill, and vote on the motion to invoke cloture on the motion to proceed to consideration of the bill. **Page S7932**

Signing Authority—Agreement: A unanimous-consent agreement was reached providing that from Thursday, November 7, 2013 through Tuesday, November 12, 2013, the Majority Leader be authorized to sign duly enrolled bills or joint resolutions. **Page S7932**

Pillard Nomination—Agreement: Senate began consideration of the nomination of Cornelia T. L. Pillard, of the District of Columbia, to be United States Circuit Judge for the District of Columbia Circuit. **Page S7923**

A motion was entered to close further debate on the nomination, and, in accordance with the provisions of Rule XXII of the Standing Rules of the Senate, and pursuant to the unanimous-consent agreement of Thursday, November 7, 2013, a vote on cloture will occur at approximately 5:30 p.m., on Tuesday, November 12, 2013. **Page S7923**

A unanimous-consent agreement was reached providing that at 4:30 p.m., on Tuesday, November 12, 2013, Senate resume consideration of the nomination, with the time until 5:30 p.m. equally divided and controlled in the usual form, prior to the vote on the motion to invoke cloture on the nomination. **Page S7932**
